- 2 AUTHORIZING THE FIRE CHIEF TO ISSUE FIRE RESTRICTIONS AND FIRE
- 3 BANS AS NECESSARY; ESTABLISHING FIRE RESTRICTION STAGES AND
- 4 PROHIBITED ACTIVITIES FOR EACH STAGE; AUTHORIZING THE FIRE CHIEF
- 5 TO DETERMINE WHEN TO IMPOSE AND LIFT STAGES; PROVIDING FOR
- 6 PENALTIES; AND DECLARING AN EMERGENCY.
- 7 BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
- **8 ALBUQUERQUE:**
- 9 Section 1. FINDINGS. The City Council finds:
- A. The City of Albuquerque has unique wildland urban interface areas comprised of the Bosque Areas of the Rio Grande State Park, Open Space Recreational Areas and Wildland areas that consist of 28,000 acres and over 100 miles of public-private border; and
 - B. There are numerous days each year, due to high winds, lack of precipitation and low humidity when the fire danger throughout Albuquerque is high; and
 - C. The Albuquerque Fire Department responds to numerous brush and Bosque fires each year within the City, responds to fires that threaten any areas for which the Fire Department has response obligation, and provides mutual aid to surrounding communities and agencies; and
 - D. Should a fire occur during times of high fire danger, it may be necessary to evacuate and relocate residents of the City; and
- E. The affected areas consist of all areas within the municipal boundaries of the City of Albuquerque, and all lands for which the City has assumed control or management responsibilities by lease, easement or legal agreement.

- 1 Section 2. SHORT TITLE.
- 2 This article may be cited as the "Albuquerque Fire Restriction Ordinance".
- 3 Section 3. FIRE RESTRICTION AND BANS.
- 4 A. The Fire Chief is hereby authorized during periods of increased fire
- 5 danger in the City, both seasonal and unexpected, that pose a significant and
- 6 immediate threat to the safety, health and welfare of the citizens, and a
- 7 significant and immediate threat to property, to issue fire restrictions and fire
- 8 bans as deemed necessary. The Fire Chief shall determine such restrictions
- 9 and bans based on current fire indices, fire behavior predictions, current and
- 10 expected weather conditions, drought indices, human factors, ignition factors
- and local factors which would put undue strain on local fire agencies should a
- 12 fire start.
- 13 B. The Fire Chief is further authorized during periods of increased fire
- 14 danger to prohibit the issuance of permits and ban all open burning and other
- 15 ignition sources in all public and private outdoor areas within the municipal
- 16 boundaries of the City of Albuquerque, and on all lands for which the City has
- 17 assumed control or management responsibilities by lease, easement or legal
- 18 agreement. Examples of such open burning and other ignition sources
- 19 include but are not limited to:
 - 1. Open burning
 - 2. Bonfires
 - 3. Recreational fires
 - 4. The use of model rockets
 - 5. Open flame devices
- 25 Section 4. IMPOSING, AMENDING AND LIFTING FIRE BANS AND
- 26 RESTRICTIONS.
- 27 A. A ban or stage of restriction shall be publicly declared by the Fire
- 28 Chief and announced through all public and private media accessible to the
- 29 Fire Chief.
- 30 B. Once a ban or restrictions has been declared by the Fire Chief, it
- 31 shall remain in effect until the Fire Chief determines that the increased fire
- 32 danger has been alleviated.

- 1 C. The Fire Chief will publicly announce that a ban or restriction has 2 been lessened or removed using the same media used to declare the ban or 3 restriction.
 - Section 5. FIRE RESTRICTION STAGES. The following Fire Restriction
 Stages are established for all Open Space Areas in the municipal boundaries
 of the City of Albuquerque. Increased fire restrictions shall be determined by
 the Fire Chief and shall be based upon current fire indices, fire behavior
 predictions, current and expected weather conditions, drought indices, human
 factors, ignition factors and local factors that would cause undue strain on
 local fire agencies in the event of a fire.
 - A. STAGE I FIRE RESTRICTIONS. The goal of Stage I Restrictions is to prevent the start of wildfires based on human activities that are known to be high risk. Based on climate and fuel conditions in the Albuquerque area, Stage I Restrictions shall be in effect at all times within all Open Space Areas as defined herein.
 - B. STAGE II FIRE RESTRICTIONS. Stage II Restrictions will be imposed when the threat of fire danger increases from conditions requiring Stage I Restrictions. This stage intensifies the restrictions from Stage I by focusing on activities that, although normally managed under permit or contract, have a relatively high risk of causing a fire to start. Stage II Restrictions limit the activities of contractors, permittees and other wildlands users in Open Space Areas. The costs and benefits of imposing Stage II Restrictions upon such contractors, permittees and wildlands users and the general public will be taken into account by the Fire Chief prior to determining to impose Stage II Restrictions.
 - C. STAGE III CLOSURE. Stage III results in the closure of specific Open Space Areas. This Stage will be implemented when ongoing emergencies pose a risk to the health and welfare of the public or when the ability to mitigate risks using Stage I or II Restrictions is no longer viable. The need to protect the public at this stage outweighs the impacts of implementing a partial or complete closure.
- 32 Section 5. PROHIBITED ACTIVITIES.

- 1 A. STAGE I. The following activities are prohibited in Open Space
- 2 Areas as defined herein while Stage I Restrictions are in effect:
- 3 1. Building, maintaining, attending or using a fire, open flame, campfire
- 4 or stove fire except within a developed recreation site.
- 5 2. Smoking, except within an enclosed vehicle.
- 6 3. Possessing, discharging or using any kind of fireworks or other
- 7 pyrotechnic device.
- 8 4. Possessing or operating a motor vehicle off any publicly designated
- 9 roadway, except when parking in developed parking lots or at developed
- 10 trailheads unless otherwise authorized by a recognized government agency
- 11 having such authority.
- 12 5. Operating a chainsaw or other equipment powered by an internal
- 13 combustion engine unless otherwise authorized by a recognized government
- 14 agency having such authority.
- 15 6. Operating any piece of spark-emitting equipment unless otherwise
- 16 authorized by a recognized government agency having such authority.
- 7. Operating any internal or external combustion engine unless
- 18 otherwise authorized by a recognized government agency having such
- 19 authority.
 - 20 8. Welding, or operating an acetylene or other torch with an open flame
 - unless otherwise authorized by a recognized government agency having such
 - authority.
 - 9. Camping or overnight stay.
- 24 B. STAGE II. The following activities are prohibited in Open Space
- 25 Areas as defined herein while Stage II Restrictions are in effect:
 - 1. Building, maintaining, attending or using a fire, open flame, campfire
- 27 or stove fire.
 - 2. Smoking.
- 29 3. Possessing, discharging or using any kind of fireworks or other
- 30 pyrotechnic device.
- 31 4. Possessing or using a motor vehicle off any publicly designated
- 32 roadways, except when parking in developed parking lots or at developed
- 33 trailheads.

- 5. Operating a chainsaw or other equipment powered by an internal
 combustion engine.
- 3 6. Operating any piece of spark-emitting equipment.
- 4 7. Operating any internal or external combustion engine.
- 5 8. Welding, or operating an acetylene or other torch with an open flame.
- 6 9. Camping or overnight stay.
- 7 C. STAGE III CLOSURE. While Stage III Closure is in effect for any or
- 8 all Open Space Areas as defined herein, it shall be prohibited to enter into or
- 9 be upon the restricted area.
- 10 Section 6. DEFINITIONS. For the purposes of this ordinance, the
- 11 following definitions shall apply.
- 12 BONFIRE. An outdoor fire used for ceremonial purposes.
- 13 BOSQUE or BOSQUE AREAS. The cottonwood corridor adjacent to and on
- 14 either side of the Rio Grande.
- 15 FIRE CHIEF. The chief officer of the Albuquerque Fire Department.
- 16 OPEN BURNING. The burning of materials wherein products of
- 17 combustion are emitted directly into the ambient air without passing through a
- 18 stack or chimney from an enclosed chamber. Open burning does not include
- 19 road flares, smudgepots and similar devices associated with safety or
- 20 occupational uses typically considered open flames, recreational fires or use
- 21 of portable outdoor fireplaces. For the purpose of this definition, a chamber
- 22 shall be regarded as enclosed when, during the time combustion occurs, only
 - apertures, ducts, stacks, flues or chimneys necessary to provide combustion
- 24 air and permit the escape of exhaust gas are open.
- 25 OPEN SPACE AREAS. Includes those lands zoned or designated as open
- 26 space in the City's adopted Plan for Major Public Open Space and acquired by
- 27 the City; Bosque or Bosque Areas; the Rio Grande State Park; Wildlands
- 28 Areas and wildlands/urban interface areas; major named arroyos; lined or
- 2 29 unlined drain-ways; retention dams and retention pond areas and abutting
- 30 rights-of-way or easements which have been publicly acquired; and any open
- 31 lands for which the City has assumed control or management responsibility
- 32 by lease, easement, or legal agreement.

1	RECREATIONAL FIRE. An outdoor fire burning materials other than
2	rubbish where the fuel being burned is not contained in an incinerator,
3	outdoor fireplace, portable outdoor fireplace, barbeque grill or barbeque pit
4	and has a total fuel area of 3 feet or less in diameter and 2 feet or less in
5	height for pleasure, religious, ceremonial, cooking, warmth or similar
6	purposes.
7	RIO GRANDE STATE PARK. The park area established in the Rio Grande
8	Valley State Park Act that has boundaries defined in Section 16-4-12 NMSA
9	1978 and is under the management of the City of Albuquerque pursuant to the
10	Rio Grande Valley State Park Act.
11	WILDLANDS AREAS. The lands owned by the City that are designated for
12	public recreational purposes and that are covered wholly or in part by timber,
13	brush or native grasses.
14	Section 7. EXEMPTIONS.
15	This ordinance shall not apply to any federal, state, or local public safety
16	officer, or member of an organized rescue or firefighting force in the
17	performance of an official duty.
18	Section 8. ENFORCEMENT.
19	The Fire Chief or his designees and the Albuquerque Police Department's
20	Open Space Officers shall enforce the "Albuquerque Fire Restriction
21	Ordinance."
22	Section 9. PENALTIES.
23	Any person convicted of violating any provision of this ordinance or failing
24	or neglecting to comply with any orders issued pursuant to any section
25	thereof shall be deemed guilty of a petty misdemeanor and such person shall
26	be guilty of a separate offense for each and every day or portion thereof
27	during which any such violation is continued or permitted. Upon conviction,
28	each such violation shall be punishable by a fine of not more than five
29	hundred dollars (\$500) or by imprisonment for not more than ninety (90) days,
30	or by both such fine and imprisonment.
31	Section 10. SEVERABILITY CLAUSE. If any section, paragraph, sentence,

Section 10. SEVERABILITY CLAUSE. If any section, paragraph, sentence, clause, word or phrase of this ordinance is for any reason held to be invalid or unenforceable by any court of competent jurisdiction, such decision shall not

		1	affect the validity of the remaining provisions of this ordinance. The Council
		2	hereby declares that it would have passed this ordinance and each section,
		3	paragraph, sentence, clause, word or phrase thereof irrespective of any
		4	provision being declared unconstitutional or otherwise invalid.
		5	Section 11. COMPILATION. This ordinance shall be incorporated in and
		6	made part of the Revised Ordinances of Albuquerque, New Mexico, 1994.
