1	WHEREAS, the City Council feels that it is in the best interest of the City for
2	this review to take place as expeditiously as possible.
3	BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
4	ALBUQUERQUE:
5	Section 1. There is hereby created an ad hoc Police Oversight Task Force.
6	The Police Oversight Task Force shall consist of eleven (11) members
7	representing the ethnic and gender diversity of Albuquerque and the following
8	interests:
9	a. A member with investigative or prosecutorial experience at the
10	district or statewide level;
11	b. Two members with non-profit advocacy experience in mobilizing
12	community groups to address social concerns;
13	c. A member with experience in an organization that defends and
14	works to preserve individual civil liberties;
15	d. A retired member of the Albuquerque Police Department;
16	e. Five members of the community at large;
17	f. A member with experience in governmental efficiency and
18	accountability.
19	The Chair and Vice-Chair of the Police Oversight Task Force will be selected by
20	a majority vote of the members of the Task Force. The Task Force shall hold
21	its meetings in compliance with the State Open Meetings Act and shall conduct
22	its meetings in accordance with Robert's Rules of Order.
23	Section 2. Duties of the Police Oversight Task Force. The Task Force shall
24	meet as many times as necessary so as to complete a thorough evaluation and
25	analysis of the police oversight process and report back to the City Council
26	with its recommendations for improving the police oversight process by the
27	end of December 2013. The Task Force shall review the history and evolution
28	of the existing police oversight system by reviewing the results and
29	recommendations of the Walker/Luna study and both the 2006 and 2011 MGT
30	studies. The Task Force shall receive briefings and presentations, as
31	necessary, from subject matter experts on the city's current oversight system,
32	and on best practices and oversight models from other cities. The Task Force
33	may request the City to engage nationally known experts in the field of police

	2	Task Force shall be provided by the City.
	3	Section 3. As an indispensable part of the Task Force's work, the Task
	4	Force will hold three Town Hall meetings in which members of the public are
	5	encouraged to provide comments or suggestions for improving the police
	6	oversight process.
	7	Section 4. An amount of up to \$50,000 is hereby designated with the City
	8	Council Projects activity to pay for consultants and services related to this
	9	resolution.
