1 RESOLUTION
2 ESTABLISHING A MEANS FOR OPEN AND TRANSPARENT ELECTION
3 FINANCING FOR MUNICIPAL ELECTIONS; DIRECTING THE CITY CLERK TO
4 PROVIDE SEARCHABLE FINANCIAL REPORTS AND A LINK TO EACH
5 CANDIDATE'S AND MEASURE FINANCE COMMITTEE'S FINANCIAL REPORTS
6 ON THE CITY'S WEBSITE.

7 WHEREAS, the filing of election finance reports is a requirement of the
8 City's municipal election process as set forth in the City Charter; and

9 WHEREAS, the City is at the forefront of open government and
10 transparency; and

11 WHEREAS, the finance reports provide information that should be easily
12 accessible to the public to ensure public trust in the municipal election
13 process; and

14 WHEREAS, the election finance reports should be easy to locate or search
15 on the City's website; and

16 WHEREAS, candidates and Measure Finance Committees are already
17 required to submit information and updates electronically, so it should not be
18 burdensome to provide easy access to those reports.

19 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
20 ALBUQUERQUE:

21 Section 1. For the purpose of open and transparent election financing, the
22 City Clerk and the City's Information Technology Services Division shall
23 provide on the City's website home page a link to the financial reports for
24 municipal candidates and Measure Finance Committees. Such reports shall be
25 available for each candidate and each Measure Finance Committee and shall




