1 RESOLUTION

2 ESTABLISHING THE AD HOC POLICE OVERSIGHT TASK FORCE; NAMING
3 MEMBERS.

4 WHEREAS, the Police Oversight ordinance requires periodic evaluations
5 so as to *"undertake a complete evaluation and analysis of the entire Police*
6 *Oversight Process, and recommend any necessary changes or amendments*
7 *that would appropriately improve the process."* §9-4-1-11 ROA 1994; and

8 WHEREAS, the City Council believes that the creation of a Police Oversight
9 Task Force is an appropriate first step in bringing expertise to bear on the
10 review of the police oversight process; and

11 WHEREAS, the City Council recently passed F/S R-13-143 which creates an
12 11-person ad hoc Police Oversight Task Force with membership that should
13 reflect the community and include 5 members of the community at large, a
14 retired APD officer, and members with experience in investigation or
15 prosecution, in non-profit/community groups, in civil liberties, in
16 governmental efficiency; and

17 WHEREAS, the City recently solicited applications from community
18 members who would be interested in and qualified to serve on the Task Force;
19 and

20 WHEREAS, the City received 115 applications from individuals requesting
21 to be selected as members of the Task Force; and

22 WHEREAS, staff has evaluated and recommended to the City Council the
23 following 11 individuals to serve on the Task Force; and

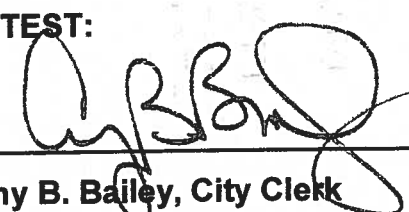
