1 RESOLUTION

2 AMENDING RESOLUTION R-13-189 (ENACTMENT NO. R-2013-054) WHICH
3 DECLARED THE FORTH SATURDAY IN JUNE “ALBUQUERQUE ADOPTION
4 APPRECIATION DAY” TO SHOW SUPPORT FOR THE FAMILIES OF CHILDREN
5 YOUTH AND FAMILIES DEPARTMENT (CYFD) ADOPTIONS AND FOR
6 FAMILIES THAT ADOPT CHILDREN ON NATIONAL ADOPTION DAY.

7 WHEREAS, Resolution R-13-189 (Enactment No. R-2013-054) was approved
8 by the City Council on June 17, 2013, and declared the forth Saturday in June
9 “Albuquerque Adoption Appreciation Day” to show support for the families of
10 children adopted in Bernalillo County through the Children Youth and Families
11 Department (CYFD) and those adopted on National Adoption Day; and
12 provided these adoptive families with annual passes to the Albuquerque
13 Biopark and Explora Museum; and

14 WHEREAS, Resolution R-13-189 required that the adoptive families claim
15 the annual Biopark and Explora passes within 60 days of the final adoption
16 date; and

17 WHEREAS, The City would like to extend the annual Biopark and Explora
18 passes to all adoptive families in Bernalillo County, regardless of adoption
19 date;

20 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
21 ALBUQUERQUE:

22 Section 1. Section 3 of Resolution R-13-189 is amended as follows:

23 “Section 3. The City shall provide annual passes to the Zoo, Biopark, and
24 Explora to families of children who are adopted in Bernalillo County [- on

26 adoptions or CYFD adoptions[- , and the City shall provide annual passes to
