2 MAKING AN APPROPRIATION TO THE ALBUQUERQUE FILM & MEDIA
3 EXPERIENCE FOUNDATION AND AUTHORIZING THE MAYOR TO ENTER INTO
4 AN AGREEMENT WITH THE ALBUQUERQUE FILM & MEDIA EXPERIENCE
5 FOUNDATION FOR THE PRODUCTION OF THE 2014 FESTIVAL.

6 WHEREAS, the Albuquerque Film & Media Experience Foundation
7 (Foundation) sponsors the annual Albuquerque Film and Media Experience
8 (AFME); and

9 WHEREAS, AFME is an event that represents creative achievement in film,
10 music, arts and entertainment; and

11 WHEREAS, AFME showcases the City of Albuquerque as a destination for
12 the creative arts; and

13 WHEREAS, in 2013, over 5,300 people, of which 70% were Albuquerque
14 residents, attended AFME events and generated \$4 million in economic
15 impact; and

16 WHEREAS, the 2014 event will showcase International Spotlights on
17 Ireland and India, a Student Art Exhibit, discussion panels on make-up, visual
18 and special effects, cinematography, documentaries and social impact, and
19 casting among other events; and

20 WHEREAS, a portion of funds raised through the events will assist the
21 Foundation in supporting organizations that address heroin awareness, child
22 and human trafficking, sexual assault, tissue and organ donation, alcohol
23 abuse and wildlife preservation, to name a few; and

24 WHEREAS, the City desires to be a sponsor of AFME; and

25 WHEREAS, there is sufficient unreserved fund balance in the General Fund
26 in FY/14 to cover this appropriation.
