1 RESOLUTION

2 DESIGNATING FISCAL YEAR 2015 GENERAL FUND APPROPRIATIONS FOR  
3 THE HEADING HOME PROGRAM. AUTHORIZING THE MAYOR TO ENTER  
4 INTO A SOCIAL SERVICES AGREEMENT WITH ALBUQUERQUE HEADING  
5 HOME FOR CASE MANAGEMENT SERVICES FOR HEADING HOME CLIENTS.

6 WHEREAS, the Mayor of Albuquerque has declared the Albuquerque  
7 Heading Home Program as one of the most effective programs in providing  
8 housing and related services, including case management, to medically  
9 vulnerable homeless people; and

10 WHEREAS, the Albuquerque Heading Home Program has been providing  
11 housing and case management to Heading Homes clients for the past three  
12 years; and

13 WHEREAS, these services have been funded through a grant from the  
14 federal Substance Abuse and Mental Health Services Administration and the  
15 grant expires September 30, 2014; and

16 WHEREAS, funding for the continuation of the case management program  
17 for the Heading Home Program was not included in the FY/15 General Fund  
18 Budget; and

19 WHEREAS, without the case management services approximately 70  
20 Heading Home clients will likely loose contact with services and ultimately  
21 may lose their housing.

22 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF  
23 ALBUQUERQUE:

24 Section 1. That those funds in the amount of Three Hundred Seventy Five  
25 Thousand Dollars (\$375,000) previously appropriated in C/S R-13-47, Exhibit A  
26 "Supportive Services to the Homeless/to be determined" is hereby designated

1 to Heading Home for the purposes of providing case management and related  
2 services for homeless persons who are medically vulnerable.

3 Section 2. That the Mayor is authorized to enter into a Social Services  
4 Agreement with Albuquerque Heading Home for case management and related  
5 services.
