2 **EXPRESSING SUPPORT FOR CORNUCOPIA ADULT AND FAMILY SERVICES**
3 **INTENT TO APPLY FOR FUNDING IN RESPONSE TO THE NEW MEXICO**
4 **DEPARTMENT OF TRANSPORTATION'S FFY 2016 APPLICATION UNDER**
5 **SECTION 5310: ENHANCED MOBILITY OF SENIORS AND INDIVIDUALS WITH**
6 **DISABILITIES TO MEET THE TRANSPORTATION NEEDS OF THE ELDERLY,**
7 **FRAIL AND DISABLED PERSONS.**

8 **WHEREAS, Cornucopia Adult and Family Services, a non-profit**
9 **organization, has been providing family-oriented services for elderly, frail and**
10 **disabled persons since 1983; and**

11 **WHEREAS, clients served by Cornucopia have a variety of conditions,**
12 **including, but not limited to, Alzheimer's, Dementia, Traumatic Brain Injury,**
13 **Schizophrenia, Developmental Disabilities, Downs Syndrome, Cerebral palsy**
14 **and Autism; and**

15 **WHEREAS, Cornucopia's Adult Day Habilitation Program serves 147**
16 **people daily; and**

17 **WHEREAS, the Adult Day Habilitation Program offers an array of off-site**
18 **activities which requires accessible transportation for the clients; and**

19 **WHEREAS, Cornucopia will be submitting a grant application for the New**
20 **Mexico Department of Transportation (FTA) FFY 2016 Application under**
21 **Section 5310 requesting funding to acquire vans specifically crafted to**
22 **accommodate wheel chairs with full motorized wheel chair lifts.**




