1 **ORDINANCE**

2 **AMENDING CHAPTER 2, ARTICLE 11, ROA 1994, CITY BUDGET, TO ALLOW**  
3 **FOR THE CARRYOVER OF GENERAL FUND RESERVES INTO SUBSEQUENT**  
4 **FISCAL YEARS WHEN THE RESERVES RELATE TO SALARY INCREASES OR**  
5 **EQUIVALENT BENEFITS FOR EMPLOYEES COVERED UNDER COLLECTIVE**  
6 **BARGAINING UNITS.**

7 **BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF**  
8 **ALBUQUERQUE:**

9 **SECTION 1. THAT A NEW SECTION IS HEREBY ADDED TO CHAPTER 2,**  
10 **ARTICLE 11, ROA 1994, CITY BUDGET, TO READ AS FOLLOWS:**

11 **§ 2-11-20 CARRYOVER OF GENERAL FUND RESERVES THAT RELATE TO**  
12 **SALARY INCREASES OR EQUIVALENT BENEFITS FOR EMPLOYEES**  
13 **COVERED UNDER COLLECTIVE BARGAINING UNITS.**

14 **At the end of each fiscal year, any outstanding amount of General Fund**  
15 **Reserves designated for employee salary increases or equivalent benefits that**  
16 **results from unsuccessful labor negotiations shall be carried forward into**  
17 **subsequent fiscal years until such time as the collective bargaining process is**  
18 **successful in reaching new labor agreements and providing the intended**  
19 **salary increases and/or benefits. Funding for the negotiated salary increases**  
20 **and/or benefits shall be appropriated beginning on the effective date of the**  
21 **new labor agreements. If new labor agreements become effective later than**  
22 **July 1<sup>st</sup> of a respective fiscal year, an amount equivalent to the salary and**  
23 **benefits reserve remaining for the period between July 1<sup>st</sup> of that fiscal year**  
24 **and the effective date of the labor agreements shall be appropriated for a one-**  
25 **time bonus to the covered employees.**

1       **SECTION 2. COMPILATION.** Sections 1 of this ordinance shall amend, be  
2 incorporated in and made part of the Revised Ordinances of Albuquerque,  
3 New Mexico, 1994.

4       **SECTION 3. EFFECTIVE DATE.** This ordinance shall take effect five days  
5 after publication by title and general summary.
