1 RESOLUTION 2 AUTHORIZING THE MAYOR TO EXECUTE THE ALBUQUERQUE BUSINESS 3 EDUCATION COMPACT RECOMMENDATIONS AND PROVIDING AN 4 APPROPRIATION TO THE DEPARTMENT OF FAMILY AND COMMUNITY 5 SERVICES. 6 WHEREAS, 0-2000-037 allowed the City of Albuquerque to issue New 7 Mexico Taxable Industrial Revenue Bonds in an aggregate principal amount of 8 \$400,000,000 on behalf of Philips Semiconductor Inc. in Fiscal Year 2000; and 9 WHEREAS, it was a condition of the Bond sale that Philips Semiconductor Inc. would contribute \$200,000 annually for the term of the Bonds, or in the 10 event the Bonds were redeemed prior to maturity, that the Company would pay

\$2.2 million for the development of educational programs for at-risk youth; and
WHEREAS, the City has designated that the Albuquerque Business Education
Compact (ABEC) would provide recommendations to the Mayor, subject to
Council approval, on the use of the Philips Semiconductor contributions; and

WHEREAS, funding to carry out these recommendations is available from ABEC Philips Clawback money in the Trust and Agency Fund 820. BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF ALBUQUERQUE:

Section 1. The Mayor is authorized to enter into agreements and take all
necessary and appropriate steps to implement approved projects in conjunction
with the Albuquerque Business Education Compact.

Section 2. That funds in the amount of Two Hundred Twenty-Seven
Thousand Dollars (\$227,000) of ABEC Philips Claw back money held in the
Trust and Agency Fund 820 is hereby appropriated to the Department of Family

# Recommendations for Philips Semiconductors' Settlement 2015

<b>I. Job Mentor Program</b> Provide funds to support scholarships for students in the Job Mentor Program to attend postsecondary education.	\$ 14,700
<b>II. Read By Third Grade Initiative</b> Read by Third Grade is a subcommittee of the Albuquerque Business Education Compact to encourage early literacy development. The group provides support resources to community groups and schools that are involved in providing early literacy skills to our young people.	\$ 11,760
<b>IV. Albuquerque Bernalillo County Community Schools Partnership</b> Support of the Albuquerque Bernalillo County Community Schools Partnership which will provide assessment, capacity building, and implementation of the community school approach at target middle schools. Funding will also be used to support evaluation to measure the impact of these investments.	\$196,000

### **Job Mentor Program**

- **Request:** \$15,000 for 2015 (\$14,700 for Job Mentor Program and \$300 indirect) for scholarships for students in the Job Mentor Program to attend post-secondary education.
- **Description:** The Job Mentor Program is a project of the Albuquerque Business Education Compact and operated by the City of Albuquerque. The Job Mentor Program offers assistance and encouragement to high school students to stay in school and graduate. The program works with students who are identified as having potential, but not graduating from high school. The program has School Based Coordinators in each school working with students to stay in school; and providing a class that builds job preparation skills and self-esteem.

The request will provide up to \$14,700 in scholarships to students in the Job Mentor Program that graduate and go on to post-secondary education. The opportunity for scholarships provides an incentive to students who would not traditionally be able to receive a scholarship to attend post-secondary education. Students, 9<sup>th</sup>-12<sup>th</sup> grade are eligible to apply. A review committee representing members of the business community reviews the applications and makes the awards.

Number served: There are 600 students in the Job Mentor Program. 10-15 students will be granted a scholarship. Average awards are approximately \$1,000.

#### **Read By Third Grade Initiative**

**Request:** \$12,000 for 2015 (\$11,760 to Read by Third Grade Initiative and \$240 indirect) to encourage early literacy development.

**Description:** The Read by Third Grade is a committee of the Albuquergue Business Education Compact (ABEC). The initiative grew out of conversations with principals about how we could support what schools are doing to improve our student's literacy skills. The primary approach is to work through existing programs and services out there in the schools and in the community. The primary message is to parents and family members to read to their children at least 10 minutes a day. The group focuses the message to parents from birth through elementary and work through over 500 Read to Me partners. Read to Me partners are schools and community groups serving children and families. Read to Me Partners are provided with free: Book markers, flyers, posters and Once Upon a Time Booklets, grocery activity sheets and other materials. Emails are sent to our Read to Me partners with resources that may be of interest to them, along with month activity calendars that groups can use with the families they serve.

> Annually the Read to Me partners have an opportunity to apply for a Book Grant sponsored by Sandia National Laboratories/Lockheed Martin. Book Grants are for up to \$500 to purchase books for the children and families they serve. Focus is on groups serving lowincome families.

> One of the big initiatives is an annual Read to Me Book Drive where new and gently used children's books are collected and then distribute them back to children and families who may not have the resources to spend on books. The distribution is done through identifying low income schools where we give them enough books so every child can pick a book of their own and take home. This is done before the summer break. Information is included about the Libraries summer reading program. The balance of the books are distributed through our Read to Me partners to enhance their program and services.

> The Read by Third Grade Committee is made up of representatives from a variety of groups concerned with literacy. The make up of the group gives us an opportunity to work together and support the goal of building our children's literacy skills.

## Albuquerque Bernalillo County Community School Partnership (ABC Community School Partnership)

**Request:** \$200,000 for 2015 (\$196,000 for ABC Community Schools Partnership and \$4,000 indirect). Provide support of the Albuquerque/Bernalillo County Community Schools Partnership, which will provide assessment, capacity building, and implementation of the community school strategy at traditional Albuquerque Public Schools.

#### **Description:**

The ABC Community School Partnership (ABC) will serve as a networking vehicle for community leaders, on multiple levels, to intentionally align and integrate their policies, practices, finances, and other resources to effectuate administrative efficiency of the funding of programs through the development of a system of community schools.

ABC will continue working closely with schools that successfully apply for funding administered by ABC to transform as the hub of their communities in order to create both a place and a set of partnerships between the school, students, families and other community resources emphasizing real-world learning and community problem-solving by bringing together many partners to plan a range of supports and opportunities for children, youth and families.

Funding will be utilized to match funding entrusted to ABC for schools to apply for, through a competitive process, supporting their development as a Community School in four capacities:

- Comprehensiveness-Responsiveness to a wide spectrum of identified needs by marshalling the full complement of partnership resources;
- Collaboration-Structured involvement of all stakeholders: educators, parents, students, funders, community members, providers, policy makers;
- Coherence-intentional alignment of resources around shared results: coordinated and integrated systems of management; and
- Commitment-Sustainability planning and activities that are employed from the start

Specifically for the hiring of a Community School Coordinator and the implementation and integration of Family and Community Engagement, Academics, Health and Support Services, and Extended Learning Opportunities.

Additionally, funding will be utilized for data collection, analysis, and the evaluation of the achievement of the following results:

- Students attend consistently;
- Students succeed academically;
- Families are involved with their children's education; and
- Schools are engaged with families and communities.
