1 RESOLUTION

2 RELATING TO CAPITAL PROJECTS; CREATING AN INDIAN SCHOOL ROAD
3 AND CHELWOOD ROAD SAFETY IMPROVEMENT PROJECT AND
4 APPROPRIATING FUNDS IN THE TRANSPORTATION INFRASTRUCTURE TAX
5 FUND 341.

6 WHEREAS, based on an analysis of the intersection of Indian School Road
7 and Chelwood Road, it was noted that stop sign visibility could be improved,
8 and that the vertical and horizontal shifts of the intersection could also be
9 improved; and

10 WHEREAS, there have been three known crashes involving vehicles that
11 after exiting the intersection in the southbound direction have left the road
12 and crashed into yards and homes near the intersection; and it appears that
13 speed and driving under the influence were the main contributors to the
14 accidents; and

15 WHEREAS, the City can provide improvements to the intersection to
16 enhance the safety of residents in the area; and

17 WHEREAS, it is in the best interest of the City for this project to be
18 completed quickly and to have the improvements done at a favorable cost.

19 BE IT RESOLVED BY COUNCIL, THE GOVERNING BODY OF THE CITY OF
20 ALBUQUERQUE:

21 Section 1. The following project is hereby created and appropriated within
22 the Transportation Infrastructure Tax Fund 341, Road Deficiencies Category:

23 DMD/Streets/Transportation Tax

24 Indian School Road and Chelwood Road

25 Safety Improvements


