Cover Analysis

1. What is it?

FY 16 Annual Objectives; Goal 5; Objective 4, Solid Waste / Clean City Plan to increase NH participation in clean-up projects.

2. What will this piece of legislation do?

The plan was to increase the participation of citizens in neighborhood associations and other volunteer groups in department sponsored clean activities, like Great American Clean Up and "Company's Coming".

3. Why is this project needed?

This is an ongoing effort to enhance the department's efforts to keep the city free of trash and debris throughout the neighborhoods. The department receives over 30,000 requests annually for large item and other items outside of these projects.

4. How much will it cost and what is the funding source?

The department provides gloves and bags to the volunteers which are purchased through the Keep Albuquerque Beautiful grant funding. A typical 25 person clean up team costs about \$550.00, which includes collection vehicles, labor, gloves, bags, and water.
