1 RESOLUTION

2 AMENDING THE ADOPTED CAPITAL IMPLEMENTATION PROGRAM OF THE  
3 CITY OF ALBUQUERQUE TO PROVIDE FOR A SOCCER STADIUM  
4 FEASIBILITY STUDY AND AUTHORIZING THE DIRECTOR OF COUNCIL  
5 SERVICES TO ENTER INTO A CONTRACT FOR COMPLETION OF THE STUDY.

6 WHEREAS, the Capital Implementation Program of the City of Albuquerque  
7 is governed by the requirements established under Section 2-12-4 ROA, 1994,  
8 which provides for amendments to the approved program; and

9 WHEREAS, the Albuquerque Sol Football Club was established in 2013,  
10 and participates in the Premiere Development League (PDL), a development  
11 league sponsored by United Soccer Leagues (USL) which forms part of the  
12 United States soccer league system and is considered the top-level men's  
13 amateur soccer competition in the United States; and

14 WHEREAS, the Albuquerque Sol Football Club is currently seeking entry  
15 into the USL, a professional men's soccer league in the United States and  
16 Canada; and

17 WHEREAS, participation in the USL requires that the Albuquerque Sol  
18 Football Club be the primary tenant or owner of a 10,000 seat stadium; and

19 WHEREAS, the popularity of soccer has increased in the Albuquerque area  
20 in recent years and construction of a professional soccer stadium would  
21 provide economic development opportunities for the City; and

22 WHEREAS, the appropriation of funding for a soccer stadium feasibility  
23 study is timely and necessary for the City to serve its citizens.
