1 RESOLUTION  
2 CALLING FOR A STUDY OF THE NEED FOR, FEASIBILITY OF AND  
3 METHODOLOGY OF IMPLEMENTATION OF CONSOLIDATING PUBLIC SAFETY  
4 SERVICES WITHIN THE INCORPORATED AND UNINCORPORATED AREAS OF  
5 BERNALILLO COUNTY; DESIGNATING FUNDING FOR THE STUDY.

6 WHEREAS, Bernalillo County has reached a population of 675,000, with the  
7 vast majority of that population (96%) residing in urban areas; and

8 WHEREAS, since 2008, the gross receipts and property taxes revenues that  
9 fund the services delivered by the City of Albuquerque and the County of  
10 Bernalillo have experienced slow, flat, or in some cases negative growth,  
11 straining the ability of these governments to provide necessary services; and

12 WHEREAS, the Bernalillo County Sheriff's Office, the Bernalillo County fire  
13 department, and the City of Albuquerque police and fire departments serve  
14 constituencies with similar demographics and often overlapping boundaries;  
15 and

16 WHEREAS, due to criteria set through national standards the  
17 aforementioned departments use substantially similar equipment to carry out  
18 their day-to-day tasks - from vehicles to service revolvers to firefighting  
19 equipment; and

20 WHEREAS, the provision of public safety services is among the most  
21 challenging tasks a community faces and expenditures for public safety are a  
22 substantial share of the budgets of both the City of Albuquerque and the  
23 County of Bernalillo; and

24 WHEREAS, these shared attributes between the Bernalillo County Sheriff's  
25 Office and the Albuquerque Police Department and the Bernalillo County Fire  
26 Department and the Albuquerque Fire Department provide an excellent

1 opportunity for consolidating these four Departments under a regional public  
2 safety agency; and

3 WHEREAS, consolidation of service delivery by local public safety  
4 agencies has been a historical method of improving service delivery in growing  
5 urban areas starting from the consolidation of the City of Las Vegas, Nevada  
6 and Clark County Public Safety Agencies in 1954 to the merger of the Charlotte  
7 North Carolina Police Department and Mecklenburg County Sheriff's Office in  
8 1993; and

9 WHEREAS, consolidation provides a higher volume of police services,  
10 lower response times, reduced overtime expenses, the elimination of  
11 duplication of effort, and lower overall operating costs. Consolidation allows  
12 first responders better access to needed resources, more training  
13 opportunities, greater flexibility in staffing, the ability to afford specialized  
14 apparatus equipment and to establish expert units; and

15 WHEREAS, the quality of delivery of public safety services is expected to  
16 rise under consolidation of agencies as a result of more efficient and  
17 coordinated use of staffing, more flexibility to meet hours of peak demand,  
18 enhanced training opportunities, improved management and supervision and  
19 more opportunities for advancement for first responders; and

20 WHEREAS, consolidation strategies can be tailored to a region's needs.

21 Different variations include:

22 - Functional: agencies combine certain functional units, such as  
23 emergency communications, dispatch, or records.

24 - Cross Deputizing; establishment of mutual enforcement and  
25 response zones where agency jurisdictions overlap.

26 - Pooled Resources: agencies authorize each other's officers and  
27 fire fighters to pool resources and improve regional service delivery for  
28 example, permitting a city police officer to make arrests in the county and a  
29 sheriff's deputy to make arrests in the city.

30 - Unification: uniting all police, fire, and emergency medical services  
31 agencies under one umbrella into a single new entity.

1 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF  
2 ALBUQUERQUE:

3 Section 1. The Director of Council Services is authorized to procure the  
4 services of a contractor to initiate and complete a study of the feasibility of  
5 consolidating the City of Albuquerque Police and Fire Departments, the  
6 County of Bernalillo Fire Department and the Bernalillo County Sheriff's  
7 Office. The study shall include, but is not limited to, the following;

- 8 1. A needs and cost/benefit analysis of consolidating public safety  
9 services in all of Bernalillo County;
- 10 2. An analysis of opportunities and challenges of consolidating public  
11 safety services;
- 12 3. An analysis of how such a consolidation could occur in a manner that is  
13 complementary to or improves the City's compliance with the  
14 provisions of the federal Court Approved Settlement Agreement;
- 15 4. Recommendations as to whether consolidation of public safety services  
16 should occur and, if so, in what manner.

17 Section 2. The Director of Council Services shall direct the contractor to  
18 work with both City and Bernalillo County staff in the course of the study,  
19 including representatives from the office of the Chief Administrative Officer,  
20 the Bernalillo County Manager, the Bernalillo County Sheriff, a member from  
21 an association or union representing police officers and a member from an  
22 association or union representing fire fighters.

23 Section 3. The amount of fifty thousand dollars (\$50,000) is hereby  
24 designated within the Council Services FY/17 general fund budget for the  
25 purposes of funding the study referred to in Section 1 above.


