#### **Project Abstract**

New Mexico is ranked 4th highest in sexual assault incidents in the United States. Albuquerque's sexual assault rate of 63.8 per 100,000 is significantly higher than the rest of the state. In November 2015, our State Auditor counted a total of 5,409 untested sexual assault kits, with Albuquerque Police Department (APD) holding 3,948 of the total. The NM Department of Public Safety (DPS) received a 2016 DOJ SAKI grant to address untested sexual assault kits in New Mexico, but they are not responsible for Albuquerque's untested kits. This proposal seeks to complement, not supplant, DPS efforts by requesting funds to build capacity, infrastructure, and analyze the untested 3,948 sexual assault kits housed at the APD's Crime Laboratory. The project design follows the recommended BJA Sexual Assault Kit Initiative (SAKI) model. The proposal will allow for the completion of a formal inventory of all unsubmitted Sexual Assault Evidence Kits (SAEKs) in APD's jurisdiction to fully document, describe, and direct solutions to the problem of untested SAEKs at APD. This project will allow APD to coordinate with DPS on the statewide tracking system, monitor the investigative work by APD's Sex Crimes Unit and strengthen the District Attorney's prosecutorial efforts. The project will also assist in the establishment of an Albuquerque-specific in the establishment of an Albuquerque-specific SAEK Multidisciplinary Team (MDT) to address individual, organizational, and systemic factors that led to the 3,948 untested SAEKs and to prevent it from happening again. The agencies involved in this project include local and state representation from the Sexual Assault Nurse Examiners (SANE) Collaborative, law enforcement, crime laboratory and the District Attorney's Office will be represented on the MDT. This group will review and revise policies, address training needs for the MDT agencies and guide victim notification processes. Lastly, the project will allow for hiring a Site Coordinator to serve as a central point of contact and ensure that the project benchmarks and deliverables are being met. This individual will be responsible for implementing grant activities, overseeing completion of the SAEKs inventory, coordinate the MDT and attend meetings to ensure Albuquerque's efforts are consistent with national best practices. The project will have a victim-centered, trauma-informed, and advocacy focus among the Rape Crisis Center, APD Sex Crimes Unit and the District Attorney's Office.

#### **Program Narrative**

#### Description of Albuquerque, New Mexico

Albuquerque, New Mexico is the 32<sup>nd</sup> largest city in the United States and is the only metropolitan community in New Mexico. Albuquerque has a population of 557,169<sup>1</sup> within a land area of 187.7 square miles. When Bernalillo County is included, the population increases to 675,551 within a landmass of 570 square miles. The median house hold income in 2014 was estimated at \$48,390. Over 46% of Albuquerque's population is of Hispanic or Latino ethnicity and 42% is White Non-Hispanic. The greater Albuquerque metropolitan area has a violent crime rate of 792.6 per 100,000 inhabitants (12<sup>th</sup> highest for metropolitan areas in the nation) and a sexual assault rate of 63.8 per 100,000 inhabitants (44<sup>th</sup> highest in the nation), a rate significantly higher than the rest of the state. <sup>2</sup>

The Albuquerque Police Department (APD) is the largest law enforcement agency in New Mexico with 1,000 sworn positions of which 853 positions are filled. APD's police force is 37% Hispanic and 55% White Non-Hispanic. Metropolitan area law-enforcement includes the APD and the Bernalillo County Sheriff's Department (BCSD).

In response to the nationwide issue of unsubmitted Sexual Assault Evidence Kits (SAEKs) the Department of Public Safety (DPS) initiated a SAEK working group and began a state wide inventory of SAEKs. This group included the NM DPS, APD law enforcement and laboratory leadership, the New Mexico Coalition of Sexual Assault Programs (NMCSAP) as well as other criminal justice and victim advocate representatives from around the state. The New Mexico State Legislature created the NM SAEK Memorial Task Force, which absorbed the SAEK working group. Both the initial work group and the subsequent task force has the full buy-

in from the City of Albuquerque and the leadership of APD, prosecutors, and partner state agencies, such as the Office of the Attorney General and Office of the State Auditor. The State Auditor continued the inventory started by the working group and conducted their own inventory and held public input meetings. APD was one of their in-depth site visit locations and was actively involved in the Auditor's assessment and report which was distributed in December 2016. APD is using the Auditor's report and national best practices as the basis to guide new City initiatives. The State Auditor released their report and concluded that our state has the highest rate of unsubmitted SAEKs per capita<sup>3</sup>.

New Mexico has two forensic crime labs with the capacity to process SAEKs: New Mexico Department of Public Safety (DPS) Forensic Laboratory Bureau (DPS/FLB) in Santa Fe and the APD Metropolitan Forensic Sciences Center (APD/MFSC) in Albuquerque. The DPS/FLB Northern Laboratory is the servicing laboratory for the entire state, with the exception of Albuquerque. APD's Forensic Science Center currently serves only Albuquerque. Prior to July 2015, Bernalillo County Sheriff's Office (BCSO) submitted their SAEKs to the APD/MFSC under a memorandum of understanding with the City of Albuquerque. Albuquerque's inventory of approximately 3,900 SAEKs includes 470 from BCSO that originated prior to mid-2015. SAEKs from BCSO collected after July 2015 are sent to the DPS/FLB in Santa Fe.

The City of Albuquerque, APD/MFSC is applying for the Bureau of Justice Assistance (BJA) Sexual Assault Kit Initiative (SAKI) grant funding to support not only the testing of unsubmitted SAEKs but to address and strengthen core areas of concern in the Department in a systematic way that forever changes the systems and culture that has allowed nearly 3,900 SAEKs to languish.

#### **Problem Statement**

The reasons for APD's high number of unsubmitted SAEKs mirror the national reasons: insufficient funding of laboratory personnel, insufficient infrastructure of computerized database and tracking systems, delayed recognition of the value and application of CODIS, and a long standing policy of testing SAEKs only as requested by the District Attorney's office for cases going to trial. The City of Albuquerque and APD leadership have fully embraced the task of resolving the problem of backlogged SAEKs and addressing the issues that have resulted in the lack of case resolution. In December 2015, APD leadership enacted a new policy that will assist in the submission and testing of all SAEKs. Storage retention policies have been increased to two years for non-reported sexual assault cases allowing victims more time to access necessary services and decide how to proceed based on their needs.

APD is moving forward with unobligated city funds to increase the investigative staff of the APD Sex Crimes Unit's cold case staff by three investigators and a half-time advocate liaison. The APD/MFSC was allotted a special appropriation of \$200,000 funds by the City's Mayor to begin the outsourcing of the oldest SAEKs to a private laboratory. While these are efforts in the right direction, they are inadequate to the City of Albuquerque's needs.

Another challenge for Albuquerque is the number, size and scope of overlapping multidisciplinary teams (MDTs) that provide support for victims of sexual assault. For example, the Albuquerque/Bernalillo Co. Sexual Assault Response Team addresses adult/adolescent sexual assault cases and the Albuquerque/Bernalillo County Child Abuse Team only addresses child physical abuse, sexual abuse, and neglect.

One of the essential components for an effective response to the issue of backlogged SAEK's is a high functioning MDT wherein criminal justice agencies can collaborate with diverse victim advocacy representatives and skilled health professionals. However, while the issues of unsubmitted SAEKs have been presented to these MDTs, evidence is not their priority. Albuquerque needed its own "SAEK MDT." In January 2017, the Albuquerque City Council created the Albuquerque Sexual Evidence Response Team (ASERT) to specifically work on the SAEK issues in Albuquerque. Intuitively, APD sees the opportunity to merge the City's drive for accountability, with the SAKI grant's vision for a community MDT to work on SAEK policies, training, tracking, etc., specific to Albuquerque's unique needs. A key component to ensuring the ASERT is an effective and productive partner is the employment of skilled and knowledgeable leadership to guide the team's efforts. APD does not have the funding for an appropriate position reflecting the required background, skills and abilities to lead this team and associated efforts in addressing the SAEK problem systemically.

APD/MFSC's current laboratory infrastructure is insufficient to test the significant number of old SAEKs. With the laboratory's current manual process, high personnel attrition and extended training times, the laboratory has been restricted to testing only SAEKs that are requested by the District Attorney's Office with an imminent court date. The City and APD leadership has made policy changes that will require all SAEK's be tested. To help in this process, APD is requesting three new analysts through city budget. Just this month, APD initiated a salary review of forensic analysts to address the retention of qualified analysts. APD is working with a contractor to review analyst productivity, robotics, and process mapping to identify areas to improve efficiency. These activities help but we need to strengthen the scientific work force at the APD/MFSC if we seriously intend to test 3,900 old, unsubmitted SAEKs and

keep the backlog from returning. The inventory of unsubmitted SAEK's will be completed working in conjunction with NM DPS as part of their 2016 SAKI award, in which they are accountable for the inventory of all unsubmitted SAEKs statewide.

APD recognizes the value of testing the old SAEKs to contribute to investigatory leads of cases, identify repeat offenders, enhance public safety by searching potential offender DNA in the Combined DNA Index System (CODIS) database, offer some victim closure and foster confidence in the criminal justice system. SAEKs from 1988 through 2003 will be outsourced with the understanding that many will not have prosecutorial actions.

Our proposal includes the challenges faced by the 2nd Judicial District Attorney's (DA) Office which serves Albuquerque and Bernalillo County. The DA's Office currently has 104 prosecutors who process nearly 25,000 cases per year. The NM Supreme Court exacted a rule (LR2-308), exclusive to Bernalillo County, which imposes strict deadlines for the production of scientific evidence. While the intent was to promote accountability, the impact has resulted in APD/FSC analyzing only cases with imminent court dates, defeating the application of DNA for early offender identification or linking sexual assault offenders among cases. The DA's Office has one Special Prosecutor for adult sexual assault, with a caseload averaging 25 indicted cases at any given time. The DA's Office also has a Crimes Against Children Unit with eight prosecutors, each with an average of 30 active cases, two-thirds of which are specific to child sexual abuse. The idea of legally processing just the impending Priority #1 cases makes the DA's work ahead seem insurmountable — never mind the number of cases resulting from the approximate 3,900 unsubmitted SAEKs. If only 5-10% of the unsubmitted SAEKs results in a viable case, without improved resources, the DA's Office will not have the capacity to address the cases requiring prosecution.

The last problem identified speaks to the resource-disparity between the two Crime Labs that analyze SAEKs in NM, APD/MFSC and DPS/FLD. Last year, NM DPS/FLD applied for and was awarded almost \$2 million in the 2016 DOJ SAKI grant cycle to address the unsubmitted SAEKs. In July 2016, our State Legislature allocated an additional \$1.2 million to DPS/FLD exclusively. Both the SAKI grant and legislative funds were allocated to support DPS/FLD in building capacity, infrastructure, and to commence analyzing the state's backlog. While DPS/FLB used the State Auditor's full count of 5,400 unsubmitted SAEKs in describing their problem statement, DPS/FLB is not assuming responsibility for Albuquerque's approximately 3,900 unsubmitted SAEKs. This grant proposal seeks to use the SAKI funds to build capacity, infrastructure, and to commence the testing of the SAEKs housed in APD's evidence unit, which is co-located at the MFSC.

In July 2016, the City of Albuquerque allotted a special increase to the APD/MFSC of \$200,000 for the outsource analysis of unsubmitted SAEKs. While these efforts will have a positive influence, it is insufficient to fully address the approximately 3,900 SAEKs.

## Project Design and Implementation

The proposed project design follows the recommended BJA SAKI Model which is consistent with the NM State Auditor's report, consistent with the Santa Fe DPS SAKI grant, and is congruent with our leadership's vision of how to move forward. Specifically, our goals are to:

1) Thoroughly examine the individual, organizational, and systemic factors that led to the approximate 3,900 unsubmitted SAEKS in our jurisdiction and to fully document, describe, and offer informed solutions to the problem at APD;

2) Support and provide leadership for the Albuquerque-specific SAEK MDT called ASERT to work effectively with community partners to identify the contributing factors that resulted in a

lack of case resolution and identify concrete methods and resources needed to improve victim support, investigative outcomes and case resolution;

- 3) Recruit and hire a Site Coordinator as a central point of contact who will implement grant activities, create a victim-centered, trauma-informed focus to the work, and ensure project benchmarks are met and project deliverables are disseminated throughout Albuquerque and become an integrated part of statewide efforts; and
- 4) Provide funding to enhance prosecutorial resources in the 2nd Judicial District Attorney's Office to specifically address cases arising from the testing of the unsubmitted SAEKs.

Specific mechanisms to achieve goals include the following objectives:

Objective 1. Hire a Site Coordinator to oversee, implement and report on grant activities. Grant funds will be used for salaries and benefits, equipment, supplies, and training. Activities for the Site Coordinator will include: manage the meeting and activities of the ASERT; participate in the other Alb/Bern Co sexual assault/abuse related MDT meetings and the statewide SAEK Memorial Task Force activities; work with APD/FSC leadership on their internal processes; partner with the DPS SAKI Grant Coordinator in the development of the statewide tracking system; identify and develop best practices and policies relating to unsubmitted SAEKs; support law enforcement Sex Crimes investigation training development and implementation; lead policy development, training and outreach on victim notification; and keep other City departments and agencies informed and involved. The Site Coordinator will ensure project benchmarks are achieved, will attend recommended national SAKI workshops and conferences, and will identify and invite appropriate team members to join activities throughout. Funds are identified for computer, supplies, and travel for training and conferences for the Site

Coordinator. The SAKI Site Coordinator will oversee victim advocate activities as outlined in Objective 2.

Objective 2. Establish a Victim Liaison within the APD Sex Crimes unit, a Victim Advocate with the Albuquerque Rape Crisis Center and a Victim Advocate with the DA's Office. Grant funds will be used for salaries and benefits, equipment and supplies, and training. These positions will coordinate and implement victim-centered services within APD Sex Crimes, the community, and DA's Office. They will be responsible for cross-training, serve as contacts for victim inquiries, participate in the community MDTs, and implement victim notification processes. The Victim Liaison within the Sex Crimes Unit will coordinate the team of detectives' victim notification efforts and be responsible for coordinating the Special Field Officers and their outreach activities.

Objective 3. By the end of the first year of SAKI grant, APD proposes to advance the legal status of cases resulting from analysis of the testing of the unsubmitted SAEKs and APD Sex Crimes Unit investigations. Grant funds will be used to hire two prosecutors and one investigator for the 2nd Judicial District Attorney's office. The DA team will be dedicated to the work resulting from SAEK analysis from SAKI funds. The DA team will coordinate with APD departments and the ASERT MDT to ensure a supportive victim-centered prosecution of sex crimes. The DA team will address Priority #1 cases identified by APD Sex Crimes by developing a triage notification system, activating early contact with victims upon DNA/CODIS results, and collaborating with ASERT and other local resources to ensure victim engagement in legal proceedings. Funds will be used for salaries and benefits, equipment and supplies, and training, both national and in-state.

Objective 4. To support the investigation of cases arising from the outcomes of the program and specifically as a result of suspects identified through the testing of unsubmitted SAEKs, APD will utilize SAKI grant funds to provide overtime to detectives in support of such investigations.

Objective 5. With 853 sworn officers, APD has a two tiered response to sexual assault, field officers and detectives/investigators. Our team has also identified the need for specialized training for the front line field officers to improve their first response, knowing that the initial contact is one of the determining factors in whether a sexual assault victim continues to engage in the criminal justice system. APD envisions a 25 person team of specially trained Field Service officers who receive special training to provide trauma-informed response, assess high-risk or lethality factors, and immediately guide sexual assault victims to resources. This plan is modeled after our Crimes Against Children Unit (CACU), which has effectively increased the rates of victim and family engagement in the investigation and subsequent legal proceedings. The specially trained field officers also act as community service liaisons with the schools, neighborhood associations, and community events. No funding source has been identified for this training, however: APD Sex Crimes has already developed an outline for training of these officers and has offered to share with our colleagues at DPS. This will foster collaboration and consistency in the training of law enforcement officers in New Mexico. DPS indicated that the further development of such training may be an allowable cost under the 2016 SAKI grant they have received as it appears congruent with their grant applications core objectives so we would partner with them to further develop this training. National research identified that a predominant reason for not testing SAEKs is "low victim credibility, victim cooperation, and lack of continued contact with the victim." APD needs to change that with enhanced knowledge and

skills through training, whether it is the continued development of in-house training or the utilization of training developed out of the DPS 2016 SAKI grant. Other training opportunities are the national and state training conferences as new staff and some of the existing Sex Crimes Unit staff need advanced training in Forensic Experiential Trauma-Informed Interviewing (FETI).

Objective 6. APD Crime Lab's current laboratory infrastructure is insufficient to test the significant number of old unsubmitted SAEKs. With the laboratory's current manual process, high personnel attrition and extended training times, the laboratory has been restricted to testing only SAEK's that are requested by the District Attorney's office with an imminent court date. APD leadership has made policy changes that will require SAEK's be tested in a timely manner. As already noted, the City of Albuquerque/ APD are requesting the funding for additional new forensic scientists through city budget. However, it will take a significant period of time to establish new positions, hire and train new scientists. In the meantime, APD is proposing the use of SAKI \$1.5 million in grant funds to outsource the testing of approximately 1,200-1,500 of the unsubmitted SAEKs. Emphasis will be placed on Priority #1 cases (within Statute of Limitations, victim cooperative, etc.). These cases typically have the most viable prosecution. APD recognizes the value of testing all SAEKs is to contribute to investigatory leads of the cases, identify repeat offenders, enhance public safety by searching potential offender DNA in the database, offer some victim closure and foster confidence in the criminal justice system. It remains the goal of the City of Albuquerque/APD to ultimately test all of the approximate 3,900 unsubmitted SAEKs as funding can be identified and resources permit.

Inherent throughout all activities will be to build an infrastructure that will be sustaining after the grant funding ends. APD will review and develop protocols and policies to support

improved coordination and collaboration among police, labs, victim service providers, and prosecutors. APD will focus resources and attention to comprehensively address sexual assault investigations and prosecutions resulting from evidence and CODIS hits from tested SAEKs. APD will implement victim-centered notification protocols and services. APD will also coordinate with our traditional rape crisis center and SANE program and include the services for marginalized populations, such as Asian Family Services, Coalition to Stop Violence Against Native Women, and Enlace Communitario, an agency dedicated to immigrant and Spanish-speaking victims.

## Capabilities and Competencies

The City of Albuquerque, APD, and community sexual assault MDT agencies are poised and ready to implement the BJA SAKI grant objectives. APD has the coherence, collaboration and momentum to move forward along with key support from leadership, as detailed in the letters of commitment.

In addition, APD's Planning Division will be responsible for fiscal and programmatic management of this grant. The Division currently manages over 40 grants with revenue exceeding \$9 million. The majority of them are either federal or federal pass-through grants. Maria Garcia-Cunningham, the current APD Planning Manager, will serve as the lead on this project. Ms. Garcia-Cunningham has a Bachelor of Science in Business Administration and a Master of Arts in Management and has over 21 years of grant management and project implementation experience.

APD has strong capacity within their Sex Crimes Unit which has four full time detectives representing a combined 30 years' experience and average retention of seven years. The current Sex Crimes Sergeant has extensive experience in investigation (homicide, vice, narcotics and sex crimes), management, internal operations, and community coordination. Three investigators were added in July 2016 as civilian contractors with prior law enforcement and investigative experience. These investigators work exclusively with the cold cases. Several Sex Crimes Unit detectives have attended the national End Violence against Women (EVAW) conferences, the FETI training held in Dallas, and the NMCSAP sponsored two-day FETI training. Sex Crimes detectives provide cross-training to the Rape Crisis Advocates, SANE nurses, Department of Health investigators, and campus security. The sergeant and detectives participate in the multiple city and state MDT meetings, maintaining active relationships with service providers. As members of this grant's planning team, APD Sex Crimes Unit fully supports the grant goals and objectives.

The Metropolitan Forensic Science Center houses both the APD forensic casework DNA laboratory, and the New Mexico DNA Identification System Administrative Center (NMDIS), the legislatively designated State DNA Indexing System (SDIS) laboratory. Although housed in the same facility and jointly administered by the APD, these two laboratories are independently managed and funded. Both laboratories comply with the SAKI grant requirements for annual quality assurance audits. Representatives from both labs laboratories are part of the planning team for this grant.

APD is committed to coordinating with state activities as well. The DPS SAKI Grant Administrator has participated in our grant planning to ensure compatibility with DPS SAKI objectives. APD and DPS have discussed strategies for sharing training resources, working on policies to ensure consistency, and collaborating on the state tracking system.

During 2017, all certified officers in NM – including APD – will receive the new one-hour officer mandated training module entitled Sexual Assault Biological/DNA Evidence: Laws, Responsibilities, Working with Crime Labs, Advocates, and Prosecutors/DA's to Enhance your Sexual Assault Investigation, developed by NMCSAP in association with the New Mexico Law Enforcement Academy Board and funded/approved by NM STOP VAWA funds.

Members of the Alb/Bernalillo County SART are also fully supporting the SAKI goals of eliminating the problem of unsubmitted SAEKs. Members from the SART agencies are involved with this application team and are committed to continuing support, including the Rape Crisis Center of Central New Mexico, the Albuquerque SANE Collaborative, and the 2nd Judicial District Attorney's Office. Additional members will be added to represent Bernalillo County Sheriff's Office and others as identified. The other Albuquerque/Bernalillo County MDT's are informed of our SAKI grant objectives and are willing to include the SAKI Site Coordinator in their meetings and work.

Albuquerque took the initiative in recruiting a retired prosecutor who has donated time and expertise in reviewing sexual assault cases that have not had their SAEKs tested. Teamed with an APD Sex Crimes cold case investigator, they have retrieved key information from case files to determine Priority 1 Cases (within Statute of Limitations, victim cooperative, etc.), cross-referenced cases with the 2nd Judicial District's Case Management System, and identified cases where the offender has been adjudicated for the crime without the SAEK being tested (these are the only SAEKs that will not be tested). The prosecutor has identified cases where the victim was not located, cases that were never turned over to the prosecutor, and cases where the SAEK

was not tested for other reasons. APD has taken preliminary steps in working with the State's Administrative Office of the Courts to search their database and APD will be summarizing/sharing this strategy with others in the state.

As mentioned earlier, New Mexico responded to the unsubmitted SAEK issues with the development of a work group that later was formally designated by our state legislature as the NM SAEK Memorial Task Force. Leadership of the Task Force is shared by DPS and the NM Coalition of Sexual Assault Programs (NMCSAP). The subsequent task force has full buy-in from sexual assault and child sexual abuse providers, advocates, law enforcement, prosecutors, and state agencies, such as the Office of the Attorney General and Office of the State Auditor. Since the beginning, APD Sex Crimes Unit and APD Crime Lab have actively participated in the state meetings. The NMCSAP Co-Chair of the SAEK Memorial Task Force brings over 16 years' experience in working with sexual assault and is actively involved with development of this grant.

## Plan for Collecting Data Required for Solicitation's Performance Measures

The BJA SAKI application requires reporting requirements that APD is committed to providing. Sample performance measures include: required data on the completed inventory; number of SAEKs that require testing; the number of SAEKs proposed for and completed by out-sourced testing; number of DNA profiles entered into CODIS; and number of CODIS hits. All CODIS hits will be reported and will include the number of forensic hits and offender/arrestee hits, hits that are in-state and out-of-state, known/unknown offenders, and for offender/arrestee hits, information regarding type, i.e. cold, warm, serial sex-offender, non-sex offender hits, etc.

Additional performance measures collected by Site Coordinator will include meetings, attendance, and policies developed. The Site Coordinator will work with the Sex Crimes Unit to capture investigations initiated, victims contacted and engaged, and other law enforcement benchmarks. The Site Coordinator will track the effectiveness of using the team of specially trained Field Service Officers as well as the effectiveness of the three advocates who represent different agencies (rape crisis, police, and DA). The Site Coordinator will work with the District Attorney's Office to identify data on prosecutorial activities relating to the unsubmitted SAEKs, such as number of cases charged, dismissed, pled, sent to trial and trial outcome. Lastly, the Site Coordinator will identify and report on performance measures resulting from the ASERT activities.
