1 RESOLUTION

2 APPROVING AND AUTHORIZING THE FILING OF A GRANT AGREEMENT WITH
3 THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES (HHS), EARLY
4 HEAD START PROGRAM AND PROVIDING AN APPROPRIATION TO THE
5 DEPARTMENT OF FAMILY AND COMMUNITY SERVICES BEGINNING IN
6 FISCAL YEAR 2019.

7 WHEREAS, the City of Albuquerque has been selected by the U.S.
8 Department of HHS to receive a long-term grant under the Early Head Start
9 Program; and

10 WHEREAS, the Mayor has been informed that the City of Albuquerque is
11 eligible for \$2,232,643 in Federal funds for early childhood development
12 activities; and

13 WHEREAS, the City of Albuquerque will apply for these grant funds for
14 which City match funds in the amount of \$414,711 City cash match and
15 \$143,450 City non cash in-kind will meet matching requirements.

16 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
17 ALBUQUERQUE:

18 Section 1. That the grant application for the Early Head Start Program from
19 the U.S. Department of HHS in the amount of \$2,232,643 is approved, and its
20 acceptance and filing with the appropriate official of the U.S. Department of
21 HHS is in all respects approved.

22 Section 2. That in the event this grant is awarded, federal funds in the
23 amount of \$2,232,643 is hereby appropriated to the Department of Family and
24 Community Services in the Operating Grants Fund (265), beginning in Fiscal
25 Year 2019.

1 Section 3. That funds in the amount of \$414,711 from the transfer to
2 Operating Grants Program of the General Fund are hereby appropriated to the
3 Department of Family and Community Services in the Operating Grants Fund
4 (265), beginning in Fiscal Year 2019, as a portion of the City's matching
5 requirement.




