1 RESOLUTION

2 AMENDING C/S R-18-18, AS AMENDED BY R-18-56, TO EXTEND THE
3 DEADLINE FOR A COMMITTEE OF PUBLIC AND PRIVATE ENTITIES TO
4 CONDUCT AN ANALYSIS OF THE 2018 INTERNATIONAL ENERGY
5 CONSERVATION CODE WITH INTENTIONS TO REPLACE THE CURRENTLY
6 ADOPTED 2009 ENERGY CONSERVATION CODE.

7 WHEREAS, C/S R-18-18, adopted on June 4, 2018, called for the creation of
8 a committee to analyze the 2018 International Energy Conservation Code
9 (IECC) against the 2015 version of the IECC and the City's currently adopted
10 2009 version of the IECC; and

11 WHEREAS, C/S R-18-18 established a deadline of three months from the
12 date of adoption for the committee to complete the analysis; and

13 WHEREAS, R-18-56 acknowledged the intention for Council Services to
14 engage with a professional consultant to provide a detailed analysis to the
15 committee for their review to inform their recommendations to the City
16 Council; and

17 WHEREAS, R-18-56 therefor extended the original deadline to December 4,
18 2018; and

19 WHEREAS, the committee is scheduled to have their first meeting to
20 discuss the analysis completed by the professional consultant on December
21 12, 2018; and

22 WHEREAS, additional time to review the various codes is required to
23 formulate a recommendation to the City Council is required.

24 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
25 ALBUQUERQUE:


