Mr. Andrew J. Lipman currently serves as Government Affairs Director on the Four Hills Village Association Board. Mr. Lipman, served as the Board Vice President of the Dr. Martin Luther King Jr. Memorial Center (MLKMC). Mr. Lipman also chaired the MLKMC Task Force for Public Safety, a coalition of ten different local organizations and served as Chair of the Albuquerque Police Oversight Task Force. Mr. Lipman, is the founder and president of Philanthropic Consulting Services, LLC. Mr. Lipman is the founding treasurer and former President of the Board of the Holocaust and Intolerance Museum of New Mexico and a founding member and former state chair of the New Mexico Human Rights Coalition. He has been a member of the Ethics Committee of the New Mexico Chapter of the Association of Fundraising Professionals, a former Chair of the Membership Development Committee of the Rotary Club of Albuquerque and Founding President of the Institute of Management Consultants New Mexico Chapter. Mr. Lipman served for eleven years as the Executive Director of the Jewish Federation of New Mexico where he received three Human Rights Awards from the City of Albuquerque most notably the Human Rights Award from the Albuquerque Human Rights Board in 2001.

A resident of Council District 9, Mr. Lipman will represent his district on the Board, replacing Mr. Christopher J. Couls, and his first term will expire February 1, 2021.
