**SUBJECT: Executive Communication - Report of FY/18 Outstanding Encumbrances Reappropriated in FY/19**

Pursuant to the Administration Code (Chapter 2, Article 11, Section 10), a report is attached of outstanding encumbrances as of June 30, 2018, which are reappropriated in Fiscal Year 2019.

Encumbrances outstanding on June 30, 2018 were reviewed by the Office of Management and Budget and the user departments. Encumbrances represent commitments against FY/18 funds for operating costs which were ordered or contracted in FY/18 but not received in FY/18. These encumbrances are commitments against FY/18 and are eligible for reappropriation. Reappropriations are made only where a department had sufficient funds remaining at the end of FY/18 to pay the outstanding encumbrances.

In the General Fund, \$2,912,000 are reappropriated to various programs and departments according to the attached report. A total of \$2,030,000 is reappropriated to other funds.
