Subject:	Report on Uses of 3/8ths Hold Harmless Gross Receipts Tax (FY2019 2nd Quarter)

A report on the uses of the three-eighths of one percent (.375%) hold harmless gross receipts tax, which took effect July 1, 2018, has been prepared and is attached. The tax is expected to generate \$49.6 million in revenue by the close of Fiscal Year 2019. After taking into account the  $1/12^{th}$  state required reserve, this leaves \$45.5 million available for appropriation. The enabling legislation mandates that at least 60% of this new tax be spent on improving public safety in the City. When youth and social service programs are included, the targeted use for public safety is closer to 78%.

For the close of the second quarter of the current fiscal year, we estimate the total expenditures at \$21.1 million, with 81.8% of those expenses categorized as "Public Safety". As you are aware, some of the additional money was targeted for new initiatives such as new positions and vehicles, making the tracking of costs fairly easy. Other costs covered by the new tax are more difficult to quantify, such as pay increases within the Police Department or restored (avoided reductions) social service contracts. The Office of Management and Budget has developed a report to track actual expenses as compared to planned expenses within the Fiscal Year 2019 Budget. The detailed report is attached to this memo.

SUBJECT: Report on Uses of 3/8 Hold Harmless Tax

This memo is in response to your request for information regarding the new  $3/8^{th}$  cent GRT tax passed by Council last spring. The tax took effect July 1, 2018 and is expected to generate \$49.6 million by the close of Fiscal Year 2019. After taking into account the  $1/12^{th}$  state required reserve, this leaves \$45.5 million available for appropriation. The enabling legislation mandates at least 60% of this new tax be spent on improving public safety in the City. When youth and social service programs are included, the targeted use for public safety is closer to 78%.

For the close of the second quarter of the fiscal year ending December 31, 2018, we estimate the total expenditures at \$21.1 million, with 81.8% of those expenses categorized as "Public Safety". As you are aware, some of the additional money was targeted for new initiatives such as new positions or vehicles, making the tracking of costs fairly easy. Other costs covered by the new tax are a bit more difficult to quantify, such as pay increases at Police or restored (avoided reductions) social service contracts. Nevertheless, the Office of Management and Budget has developed a report to track the expenses based on the plan put forth in the Fiscal Year 2019 Budget.
