SUBJECT: Approval of Supplement to Pixegon, Inc. Professional/Technical Contract

The City of Albuquerque currently supports and uses multiple transit smartphone apps: ABQRide, ABQRide+, and ABQRideTix. The City of Albuquerque needs to replace the three applications with one Transit Mobile Application. This new app will combine the best assets from the three existing apps into one hybrid app. Additionally, new features are to be designed to improve the user interface including critical updates for sight-challenged passengers and different language options for non-English speakers.

To complete the Transit Mobile Application, the Transit Department is seeking City Council approval of a Supplemental Agreement with Pixegon, Inc. in the amount of \$72,815.63. This procurement is authorized under Section 5-5-20(N) of the Public Purchases Ordinance, which authorizes purchases of ancillary services to match software in use. The Supplemental Agreement is attached for City Council review.

Cover Analysis

1. What is it?

A Supplement Agreement with Pixegon, Inc. for the development of the ABQ RIDE + App. 2.0 Transit Mobile Application.

2. What will this piece of legislation do?

This legislation authorizes the Administration to sign a supplemental agreement with Pixegon, Inc. to complete the development of the ABQ RIDE+ App. 2.0 Transit Mobile Application.

3. Why is this project needed?

The City of Albuquerque currently supports and uses multiple transit smartphone apps: ABQRide, ABQRide+, and ABQRideTix. This new app will combine the best assets from the three existing apps into one hybrid app. The same developer who created the ABQ RIDE+ app is creating the new enhanced app. New features will improve the user interface, such as critical updates for our sight-challenged passengers and different languages for non-English speakers. Combining the most useful features into one comprehensive app will streamline and simplify route, schedule and ticketing information for all riders. The money saved by replacing the old mobile ticketing app will be used to maintain and enhance the new, consolidated app.

Additionally, the new and improved app will provide data on ridership demographics and usage analytics. These functions will allow ABQ Ride to remain on the cutting edge of transit app technology while efficiently delivering information to our riders

4. How much will it cost and what is the funding source?

The Supplemental Agreement is for \$72,815.63. The funding source is the Transit Operating Fund 661.

5. Is there a revenue source associated with this Plan? If so, what level of income is projected?

FIRST SUPPLEMENTAL AGREEMENT

THIS FIRST SUPPLEMENTAL AGREEMENT is made and entered into this ____ day of _____, _____ by and between the City of Albuquerque, New Mexico, a municipal corporation (hereinafter referred to as the "City"), and Pixegon, Inc., a New Mexico Corporation, P.O. Box 65372, Albuquerque, New Mexico, 87193 (hereinafter referred to as the "Contractor").

RECITALS

WHEREAS, the City and Contractor entered into an Agreement, dated October 26, 2018, hereinafter referred to as the "Original Agreement", whereby the Contractor agreed to render certain professional services to the City, and

WHEREAS, the Contractor developed the ABQ RIDE+ APP 2.0 Transit Mobile Application for the Albuquerque Rapid Transit Project; and

WHEREAS, the City currently supports and uses multiple transit smartphone apps: ABQRide, ABQRide+, and ABQRideTix; and

WHEREAS, the City is needing to replace the three applications with one Transit Mobile Application; and

WHEREAS, this new app will combine the best assets from the three existing apps into one hybrid app and include new features to improve the user interface, updates for sight challenged passengers and translation for users who speak languages other than English; and

WHEREAS, the City is authorized to procure the additional related services under Section 5-5-20(N) of the Public Purchases Ordinance, which authorizes purchases of ancillary services to match software in use; and

WHEREAS, the additional Services shall also require an increase in compensation and an extension of the term; and

WHEREAS, the Contractor is agreeable to the changes.

NOW THEREFORE, in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

1. Section 1 Scope of Services of the Original Agreement is hereby amended to read as follows:

Scope of Services. Provide professional services for the development and Application Support of the ABQ RIDE+ APP 2.0 Transit Mobile Application for the Albuquerque Rapid Transit Project, as set forth in

Exhibit A attached hereto and incorporated herein. Provide additional professional services the development and Application Support of the ABQ RIDE+ APP 2.0 Transit Mobile Application for the Albuquerque Rapid Transit Project, as set forth in Exhibit A-1 attached hereto and incorporated herein.

2. Section 2 Time of Performance of the Original Agreement is hereby amended to read as follows:

Time of Performance. Services of the Contractor shall commence upon execution of this Agreement, and shall be undertaken and completed in such sequence as to assure their expeditious completion in light of the purposes of this Agreement; provided, however, that in any event, all of the Services required hereunder shall be completed June 30, 2020.

3. Section 3 Compensation of the Original Agreement is hereby amended to read as follows:

A. **Compensation.** For performing the Services specified in Section 1 hereof; the City agrees to pay the Contractor up to the amount of One Hundred Thirty Six Thousand Nine Hundred Forty and 63/100 Dollars (\$136,940.63), which includes any applicable gross receipts taxes and which amount shall constitute full and complete compensation for the Contractor's Services under this Agreement, including all expenditures made and expenses incurred by the Contractor in performing the Services.

4. Except as herein expressly amended, the terms and conditions of the Original Agreement shall remain unchanged and shall continue in full force and effect unless there is a conflict between the terms and conditions of the Original Agreement and this First Supplemental Agreement, in which event, the terms and conditions of the First Supplemental Agreement shall control.

5. This Agreement shall not become binding upon the City until approved by the highest approval of authority of the City required under this Agreement.

IN WITNESS WHEREOF, the City and the Contractor have executed this First Supplemental Agreement as of the date first above written.
