FEASIBILITY STUDY FOR ESTABLISHING AN ABQ BIOPARK ENTERPRISE FUND FISCAL ANALYSIS OF THREE TO FOUR MORE SUMMERFESTS ON CIVIC PLAZA PLAN TO INCREASE USE OF THE KIMO THEATRE FOR LIVE PREFORMANCES

PRIORITY OBJECTIVE 4:

Complete a feasibility study for establishing a BioPark Enterprise Fund that includes and analysis of the admissions fee/rate needed for the BioPark to become self-sufficient.

Without sufficient resources to fund a \$30,000 feasibility study, Cultural Services Department completed an in-house analysis to determine what would be needed to establish the BioPark as an Enterprise Fund. The analysis shows that single admission ticket prices would need to be increased between 110% and 142% just to allow the BioPark to cover its approximate \$18.5 million operational expenditures.

Using the projected paid attendance number of 606,000 in FY/19, \$6.8 million would to be collected in admission fees (based on current non-resident pricing), leaving more than a \$9 million shortfall in operational expenditures. The BioPark receives approximately \$2.5 million annually from the NM BioPark Society through the Special Revenue Fund 235.

To be self-sufficient, the BioPark's a single admission tickets would need increase as follows: Adults from \$14.50 to \$35.00; Child from \$6 to \$12.50; and Senior from \$7.50 to \$15.75. This increase will be cost prohibitive for many New Mexico families and those with income insecurity. As a result, the BioPark will most likely experience a decrease in overall attendance which would require an additional increase in admissions fees.

PRIORITY OBJECTIVE 5:

Complete a fiscal analysis of the addition of three to four annual Summerfest events in Civic Plaza.

Albuquerque Summerfests are free, family-friendly community events hosted by the City of Albuquerque's Cultural Services Department. There are currently four Albuquerque Summerfest events that take place in different parts of the city:

- Heights Summerfest- North Domingo Baca Park- 15,000 event attendees
- Route 66 Summerfest- Central Ave. in Nob Hill- 50,000 event attendees
- Downtown Summerfest- Civic Plaza- 10,000 event attendees
- Westside Summerfest- Cottonwood Mall- 10,000 event attendees

Each event costs between \$80,000 and \$100,000 and are financed by the general fund.

The addition of four Summerfest events will cost an approximately \$400,000 plus an addition of at least one full-time employee for the Special Events Staff.

A variety of factors go into selecting the locations for Albuquerque Summerfest events. The ideal location needs to be a minimum of 450,000 square feet of flat area near adequate parking. Each location needs to be able to accommodate:

- Large stage with room for a secure backstage area
- Artisan Market with up to 50 booths
- 15 food trucks
- Kids' activities including inflatables, climbing walls, and face painting tents
- Microbrew Garden with up to 20 local vendor booths in a large fenced area
- Multiple banks of portable restrooms
- Adequate parking to accommodate event attendees and vendors
- Public safety vehicles including the APD and AFR command vehicles, fire trucks, and ambulances
- Sponsor display vehicles and static displays

PRIORITY OBJECTIVE 6:

Develop a plan to increase the use of the KiMo Theatre for live performances and musical events.

The Cultural Services Department's launched a Partnership Program in the fall of 2018. CSD has already seen an increase in partnership applications from community organizations inquiring about music events, book launch events, and live performances. Over the next few years, the KiMo Theatre will continue to connect and engage local groups, including nonprofits, to encourage organizations to apply for partnership opportunities. The KiMo will also explore ways to expand current partnerships with groups like the New Mexico Humanities Council.

The KiMo Theatre has developed a six point plan to make the venue, as highlighted in the Mayor's Economic Development Plan, "The Hub of the Film Community." The six basic programming ideas planned to be implemented by calendar year 2019 are:

- 1. Festivals and local productions
- 2. Minimum of 6 Major Cast/Crew Screenings
- 3. Classics & Conversations series
- 4. Screenwriting Conference/Festival
- 5. KiMo Special Events
- 6. KiMo rentals and film series

In the last year, six private cast and crew screenings have been held at the KiMo:

- 1. Ideal Home- June 23, 2018
- 2. Sicario- June 28, 2018
- 3. Ballad of Buster Scruggs- November 11, 2018
- 4. Creed II- November 19, 2018
- 5. Cliffs of Freedom- March 17, 2019
- 6. NM Film Makers Showcase- May 10, 2019

The following film festivals and events have occurred at the KiMo in the last year or are scheduled for this calendar year:

- AFME (Several years in the past) and currently set for September, 2019
- 48 Hour Film Project (Several years in the past) and currently set for- August 1, 2, & 8, 2019. (City has sponsored in the past).
- Cine Latino- September 2018
- NM PBS- Native Americans TV series premiere of Episode 1- October 19, 2018
- NM PBS/Chris Shuller's Osimi (narrated by Ali McGraw)- November 10, 2018
- NM PBS- An Awakening in Taos Mable Dodge Lujan (narrated by Ali McGraw) February 17, 2019.
- Indigenous Comic Con- November 8 & 9, 2019
- Basement Films Experiments in Cinema (Brian Konefsky)- April 17, 2019
- UNM Interdisciplinary Film & Digital Media Department- May 9, 2019

City/KiMo sponsored concerts will require a significant increase in operational funding for artist fees and hospitality. (An average AMP concert will cost about \$20,000 for artistic fees, tech support, hospitality, and marketing.) City/KiMo sponsored classic film series can be funded for about \$15,000 for a total of 20 to 25 films.

Current 2019 year-to-date events include:

- Three contracted rentals with AMP Concerts (with a minimum of six additional AMP concerts in progress for 2019)
- Joe Anderson Werks holds pending offer and routing
- Best of Burque Music Showcase (March 2019)
- Santa Fe Opera's annual student outreach tour (mid-April)
- The FUSION Theatre Company has two annual "pay what you wish" performances at the KiMo
- New Mexican Young Actors present Beauty and the Beast and this fall Peter Pan.
- St. Louis based Emery Entertainment Men Are from Mars Women Are from Venus will return for one performance of Robert Dubac's newest Off-Broadway hit, The Book of Moron.
- Annual Albuquerque Magic Show Hocus Pocus
