1 RESOLUTION

2 ESTABLISHING A PROCESS TO GATHER AND INCLUDE NEIGHBORHOOD
3 INPUT IN THE DEVELOPMENT OF THE CAPITAL IMPROVEMENT PROGRAM
4 OF THE CITY OF ALBUQUERQUE THROUGH COMMUNITY PLANNING AREA
5 ASSESSMENTS AND COMMUNITY TOWN HALL MEETINGS

6 WHEREAS, it is the policy of the City of Albuquerque that the Capital
7 Improvement Program supports the Albuquerque/Bernalillo County
8 Comprehensive Plan and adopted growth policies for urban development and
9 conservation; and

10 WHEREAS, in the past, the Capital Improvement Program (CIP) planning
11 process included the solicitation of input from the community for area specific
12 capital priorities through a series of neighborhood meetings and town halls;
13 and this input was considered during the development of the program through
14 a collaborative effort between the City Council and Mayoral Administration;
15 and

16 WHEREAS, the Integrated Development Ordinance (IDO) requires that the
17 City conduct Community Planning Area (CPA) Assessments for analysis and
18 long-range planning within each CPA established by the Albuquerque/
19 Bernalillo County Comprehensive Plan; and

20 WHEREAS, the City Council relies on input from its constituents to assist
21 in the prioritization of capital projects within Council Districts; and

22 WHEREAS, the City's Capital Improvements Ordinance requires updates to
23 reflect recent legislative changes to the City's land use regulations, such as
24 the IDO, as well as other legislative and administrative changes.

25 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
26 ALBUQUERQUE:

1 **SECTION 1. The preliminary planning process for the upcoming 2021**
2 **Capital Improvements Program shall include scheduled community town hall**
3 **meetings in each Council district, for the purpose of gathering information on**
4 **specific community capital needs and priorities through a collaborative effort**
5 **between the City Council and Mayor’s Administration. The information**
6 **gathered at these meetings will be summarized and provided to the Capital**
7 **Improvements Committee in to inform the CIP development process. The**
8 **meetings shall be held during the spring and early summer of 2020, in order for**
9 **timely submission to the Committee before it convenes in late summer of 2020.**

10 **SECTION 2. The development process for future Capital Improvement**
11 **Programs shall include the consideration of information provided through the**
12 **IDO CPA Assessments, including to the urban development and long-range**
13 **planning needs of each area.**

14 **SECTION 3. It is the intention of the City Council to include the**
15 **requirements of Sections 1 and 2 of this Resolution in future amendments to**
16 **the Capital Improvements Ordinance, to ensure that community needs are**
17 **considered during CIP planning and development .**
