Purpose:

Budget Objective 6:

Develop and conduct a survey to senior meals recipients to assess the quality of food provided and user satisfaction with meal delivery services. Submit a summary of survey results to the City Council by the end of the second quarter of FY/20.

Summary:

755 surveys were collected, reviewed and entered into a spreadsheet from multiple meal sites. All of the surveys were collected from July 2019 through November 2019. From the survey, feedback is requested about the quality of meat, vegetables, bread, low fat milk, dessert, proper temperature, greasy, and any additional comments.

Home Delivered Meal surveys are being re-evaluated to determine how a greater response from customers can be realized. A follow up from this area of services can be available at the end of the FY20 3rd Quarter.

To ensure survey data entry, five surveys were randomly selected and verified for accuracy where all five surveys tested positive.

In the graph below, 595 surveys recorded that the meals were rated as "Good, nearly 80%, while 15% were rated "Fair" and 5% as "Poor."

Nutritional Standards: Meals are planned and scheduled in three month periods. Meals must meet federal nutritional guidelines as each menu item must be calculated and proportionate to achieve a balanced meal. Respondents asked for more variety in the menu planning, which can be considered, however each meal must achieve balanced guidelines.
