Administration Services"

The City of Albuquerque's Human Resources Department, Insurance and Benefits Division in conjunction with the Department of Finance, Purchasing Division, issued the RFP for COBRA Administration Services.

The RFP was posted on the Purchasing E-Procurement, Bonfire website on January 10, 2020 and advertised in the Albuquerque Journal on January 12, 2020.

The City received four (4) responses to this solicitation. The ad hoc evaluation committee evaluated and scored the proposals received in accordance with the evaluation criteria published in the RFP. After thoroughly reviewing and scoring the proposal, P & A Administrative Services, Inc., earned the highest score of 943 points. The ad hoc committee found P & A Administrative Services, Inc to be both responsive and qualified and recommends an award to P & A Administrative Services, Inc.

I concur with this recommendation.

The City of Albuquerque's Human Resources Department, Insurance and Benefits Division will manage this contract.

The Human Resources Department will contract with a Third Party Administrator to provide the COBRA Administration. In FY21, it is estimated that the contract will be \$3,904 above the current appropriation. The fund will bring in revenues to cover the projected expense.

The funding source is an internal service fund for medical benefits.

5. Is there a revenue source associated with this Plan? If so, what level of income is projected?

The Self-Funded Health Fund will maintain revenues by charging the participating employees and their dependents a sufficient amount to cover part of the projected costs.
