R-20-61 SPONSORED BY: Isaac Benton, by request 1 RESOLUTION APPROVING THE FAMILY AND COMMUNITY SERVICES CONTRACT LISTING 2 3 **FOR FISCAL YEAR 2021** WHEREAS, the estimation of future New Mexico Gross Receipts Tax, 4 Lodgers' Tax and other revenue sources will need to be re-assessed given the 5 effect of the Public Health Order on local non-essential businesses; and 6 7 WHEREAS, due to the Public Health Emergency, on March 16, 2020, the NM Department of Finance, Local Government Division, issued Memorandum BFB 8 #20-204 to allow NM municipalities to submit their FY/20 budget as their FY/21 9 10 budget until a FY/21 budget can be meaningfully forecast; and Bracketed/Strikethrough Material] - Deletion 11 WHEREAS, on April 13, 2020, the City Council approved Resolution R-20-31 [Bracketed/Underscored Material] - New (Enactment No. R-2020-035) to approve the interim FY/21 Operating Budget of 12 the City, which included appropriations to the Family and Community Services 13 14 Department for social service contracts; and 15 WHEREAS, in accordance with the City's Purchasing Ordinance §5-5-19(A)(4), social service contracts exceeding \$150,000, or amendments causing 16 the amount of a social service contract to exceed \$150,000, must be approved 17 by the City Council, except that City Council approval shall not be required if 18 the goal, amount and contractor of any such contract or amendment is 19 included in the City of Albuquerque annual performance plan or has been 20 previously approved by the Council in an appropriating resolution; and 21 WHEREAS, the list of proposed social service contracts for FY/21 was not 22 23 included as part of the annual performance plan presented with R-20-31; and 24 WHEREAS, the approval of the social service contract listing is necessary and timely to ensure continued operation of vital services to the community. 25
