1 **RESOLUTION**
2 **AMENDING APPROPRIATIONS FOR THE CORONAVIRUS SUPPORT AND**
3 **RECOVERY PROGRAM**

4 **WHEREAS, on March 11, 2020, Governor Michelle Lujan Grisham issued**
5 **Executive Order 2020-004, Order Declaring a State of Public Health Emergency**
6 **relating to the spread of COVID-19; and**

7 **WHEREAS, in subsequent weeks the New Mexico Department of Health**
8 **issued orders limiting public gatherings and requiring non-essential**
9 **businesses to close or limit business activity; and**

10 **WHEREAS, through Resolution R-20-30 the City Council reallocated**
11 **unused General Fund appropriations to create the Coronavirus Community**
12 **Support and Recovery Fund (the “Fund”); to be used for COVID-19 needs,**
13 **including but not limited to grants to non-profits providing food, shelter, and**
14 **health services for low income and at-risk residents whose economic situation**
15 **has been negatively impacted by the 2020 COVID-19 pandemic; and**

16 **WHEREAS, through Resolution R-20-45, the City Council approved the**
17 **recommendations of award for the Fund as submitted by the Coronavirus**
18 **Community Support and Recovery Oversight Committee; and**

19 **WHEREAS, two of the organizations previously awarded a grant under the**
20 **CCSR program ultimately did not accept their awards; and**

21 **WHEREAS the Coronavirus Community Support and Recovery Oversight**
22 **Committee recommends reallocating the returned funds to supplement**
23 **awards for other participant organizations.**
