1 RESOLUTION

2 APPROVING AND AUTHORIZING THE FILING OF THE ATTACHED GRANT
3 APPLICATION FOR A FINE PARTICULATE MATTER AIR MONITORING GRANT
4 WITH THE U.S. ENVIRONMENTAL PROTECTION AGENCY AND PROVIDING AN
5 APPROPRIATION TO THE ENVIRONMENTAL HEALTH DEPARTMENT IN FISCAL
6 YEAR 2020.

7 WHEREAS, the Environmental Health Department has a performance measure
8 that it will protect and enhance the air quality for current and future generations
9 and thereby protect public health, economic well-being and aesthetic values for
10 the community (Bernalillo County); and

11 WHEREAS, the operation of the Air Quality Programs of the Environmental
12 Health Department provides the technical means of accomplishing these goals;
13 and

14 WHEREAS, the City of Albuquerque is desirous of applying for these federal
15 funds for which no City funds are required for FY 2020; and

16 WHEREAS, Congress has provided the U.S. Environmental Protection Agency
17 with special funding to address special projects designed to enhance public health
18 by reducing air pollution.

19 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
20 ALBUQUERQUE:

21 Section 1. That the attached application for the Fine Particulate Matter Air
22 Monitoring Grant in the amount of \$303,992 for the period of April 1, 2020
23 through March 31, 2022, is hereby approved and its submission and filing with
24 the appropriate official or office of the Environmental Protection Agency is in all
25 respects approved.
