WHEREAS, on March 11, 2020, Governor Michelle Lujan Grisham issued 4 Executive Order 2020-004, Order Declaring a State of Public Health Emergency 5 6 relating to the spread of COVID-19; and 7 WHEREAS, in subsequent weeks the New Mexico Department of Health issued orders limiting public gatherings and requiring non-essential 8 businesses to close or limit business activity; and 9 WHEREAS, through Resolution R-20-30 the City Council reallocated 10 Bracketed/Strikethrough Material] - Deletion unused General Fund appropriations to create the Coronavirus Community 11 [Bracketed/Underscored Material] - New 12 Support and Recovery Fund (the "Fund"); to be used for COVID-19 needs, including but not limited to grants to non-profits providing food, shelter, and 13 health services for low income and at-risk residents whose economic situation 14 has been negatively impacted by the 2020 COVID-19 pandemic; and 15 WHEREAS, through Resolution R-20-45, the City Council approved the 16 recommendations of award for the Fund as submitted by the Coronavirus 17 Community Support and Recovery Oversight Committee; and 18 WHEREAS, two of the organizations previously awarded a grant under the 19 20 CCSR program ultimately did not accept their awards; and WHEREAS the Coronavirus Community Support and Recovery Oversight 21 Committee recommends reallocating the returned funds to supplement 22 awards for other participant organizations. 23 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF 24 25 ALBUQUERQUE:
