- § 2-4-13 FILING OF PETITIONS. 6
- (B) Persons submitting petitions in accordance with Section 4, Article II of the 7
- City Charter shall collect all signatures on such petitions during the following 8
- 9 periods in the year of the election:
 - (1) For Mayoral candidates who are seeking public financing, starting 199 days before the election, and ending 136 days before the election;
 - For Mayoral candidates who are seeking private financing, starting **(2)** 147 days before the election, and ending 84 days before the election;
 - For Council candidates who are seeking public financing, starting (3) 155 days before the election, and ending 120 days before the election; and
 - For Council candidates who are seeking private financing, starting 119 days before the election, and ending 84 days before the election; (C)Petitions gathered pursuant to the provisions of Subsection (B) shall be submitted to the City Clerk for verification every Tuesday by 12:00 p.m. during the petition gathering period.
 - For Mayoral candidates seeking public financing, the final (1) submission of petitions is due to the City Clerk no later than 5:00 p.m. 136 days before the election.
 - For Mayoral candidates seeking private financing, the final **(2)** submission of petitions is due to the City Clerk no later than 5:00 p.m. 84 days before the election.
 - (3) For Council candidates seeking public financing, the final submission of petitions is due to the City Clerk no later than 5:00 p.m. 120 days before the election.
 - For Council candidates seeking private financing, the final (4) submission of petitions is due no later than 5:00 p.m. 84 days before the election.
