AND CLARIFY BOARD RELATONS TO MUNICIPAL HIRING PRACTICES. WHEREAS, the City of Albuquerque Code of Ordinances contains within 7 Chapter 10: Amusement, Recreation, Culture articles that establish and enable seven boards and commissions that advise the administration and the City Council on cultural venue and programming operations; and Deletion 11 WHEREAS, the boards and commissions of the cultural venues and program are outdated and inconsistent; and WHEREAS, the Cultural Services Department seeks to standardize to the 13 appropriate extent possible the various boards and commissions for each of the cultural divisions with uniform appointment processes, term definitions and 16 advisement duties; and 17 WHEREAS, Articles 2, 4, 5 and 6 address the specific board and 18 commission for the Albuquerque BioPark, the Albuquerque Museum, Explora, 19 the Anderson Abruzzo Albuquerque International Balloon Museum, 20 Albuquerque Public Art Program and the Libraries; and 21 WHEREAS, Article 4, Parts 3 and 4 address defunct or other governmental 22 agencies no longer within the purview of the city. 23 BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF

- 1 SECTION 1. CHAPTER 10: AMUSEMENTS, RECREATION AND CULTURE,
- 2 ARTICLE 2: ZOO; AQUATIC PARK; BOTANICAL GARDEN, PART 2:

- 17 (12) appointed members and one (1) assigned member. There shall be one
- 18 member of the Board appointed from each City Council District, three (3)
- 19 members appointed by the Mayor, who serve at large, and one (1) assigned
- 20 member from the recognized support organization of the New Mexico BioPark
- 21 Society.
- 22 (B) When an appointed vacancy on the Board occurs, the Councilor
- 23 representing the District in which the vacating member of the Board resides,
- 24 shall nominate two members to the Board who reside in his or her respective
- 25 Council District and the Mayor shall appoint one of these recommended
- 26 members; provided, however, if a member is eligible for reappointment to the
- 27 Board and the Councilor in whose District that member resides desires to

- 10 shall be staggered so that three members are eligible for reappointment or

- 12 (C) Except as provided in this article, the qualifications, appointment and

- 14 organizational structure of the Board and its subcommittees shall be governed
- 15 by §§ 2-6-1-1 et seq., the Public Boards, Commissions and Committees
- 16 Ordinance.
- 17 (D) The Board shall establish and adopt bylaws as may be necessary to
- 18 conduct elections, provide notice of meetings and otherwise govern its
- 19 proceedings.
- 20 (E) Members of the Board shall be broadly representative of all zoological
 - fields. They shall include persons who are widely known for their professional
 - competence and experience in zoology, botany, or the conservation of
- 23 nature and knowledgeable lay persons.
- 24 (F) Appointed members of the Board may not serve on the board of directors
 - for any recognized organization supporting the Albuquerque BioPark except for
- 26 the position assigned by title described in section (A) of this provision. Each
 - assigned member shall serve on the Board until the term expires with the
 - respective organization.
- 29 (G) Conflict of Interest. This provision (G) supplements § 2-6-1-4. A Board or
- 30 a subcommittee member having a financial interest in the outcome of any
- 31 policy, decision, or determination before the Board or subcommittee on which
- 32 he serves shall, as soon as possible after such interest becomes apparent,
- 33 disclose to each of the other members voting on the matter the nature of his

- **3 § 10-2-2-3 POWERS AND DUTIES.**
- 4 (A) The Board shall advise the Mayor and City Council concerning policy and
- 5 programming issue proposals pertaining to the Biological Park.
- 6 (B) The Board shall encourage the greatest use of the Biological Park
- 7 facilities and programs by the community and region.
- 8 (C) The Board shall keep itself informed of the needs of the Biological Park
- 9 and serve as a forum for discussion.
- 10 (D) The Board shall meet at least quarterly, and may hold additional meetings
- 11 at its discretion.
- 12 (E) The Board shall prepare and submit an Annual Report of its activities to
- 13 the Mayor and CAO.
- 14 (F) Staff support for the Board will be provided by the Albuquerque
- 15 Biological Park Division of the Cultural and Recreational Services Department.

- 21 defined by Board policy, shall be administered by the Museum Foundation.
- 22 unless the donor requests otherwise; in this role, the Museum Foundation shall
- 23 act as trustee for the city, and title shall vest in the city. Sections 10-4-1-1 et
- 24 seq. shall not bar the Museum Foundation from owning property specifically
 - given or sold to the Foundation.
- 26 (C) All funds which the donor requests to be deposited in the Museum Trust
 - and Agency Account shall be invested as part of the established city investment
- 28 program, unless a specific fund is to be used immediately and the Director
- 29 requests other use or deposit. Proceeds from these investments shall be
- 30 credited to the Museum Trust and Agency Account and are not to be substituted
- 31 for public funds in determining the financing of the Museum by the city.
- 32 (D) The Director is empowered to expend funds from the Museum Trust and
- 33 Agency Account in accordance with applicable city practices.

- 1 § 10-4-1-9 STATEMENT OF POLICY.
- 2 (A) The City Council will assume the cost of operating the Museum,
- 3 specifically, salaries of staff and employees, costs of preparing exhibitions,
- 4 maintenance of building and grounds, and other related costs and services.
- 5 (B) Costs of acquisition of collections and similar material for the Museum
- 6 will not normally be paid for by the city unless special funds are made available
- 7 to the city by grants, endowments, gifts or by Council action. The Museum may
- 8 charge admission fees. For special projects which are beyond the usual
- 9 operating activities of the Museum, hereinafter "special project," the Museum
- 10 may request special funds from the City and/or grants from outside
- 11 sources. The request for a grant may include all the costs of the special
- 12 project. Thus, if a special project requires additional personnel or special
- 13 equipment exclusively for that project, the grant may encompass the expenses
- 14 as costs arising from that project, expenses which the Museum would not
- 15 otherwise undertake.
- 16 (C) Admission fee levels shall be set by the Mayor, in consultation with the
- 17 Board, pursuant to the following policies:
- 18 (1) Fees should not be so high as to seriously reduce the availability of the
- 19 Museum to the public;
 - (2) Fees should be reasonable in relation to other museum and educational
- 21 attractions in the Southwest region;
 - (3) Compatible, reciprocal fees with the New Mexico Museum of Natural
- 23 History are desirable;
 - (4) In keeping with the museum's educational role, special fee provisions

- 6 eleven members. There shall be one member of the Albuquerque Arts Board
- 7 from each City Council District and (2) two members appointed by the Mayor
- 8 who serve at large. When a vacancy on the Albuquerque Arts Board occurs, the
- 9 Councilor representing the District in which the vacating member of the
- 10 Albuquerque Arts Board resides, shall nominate two members to the
- 11 Albuquerque Arts Board who reside in his or her respective Council District and
- 12 the Mayor shall appoint one of these recommended members; provided,
- 13 however, if a member is eligible for reappointment to the Arts Board and the
- 14 Councilor in whose District that member resides desires to reappoint the
- 15 member, the Councilor shall so notify the Council and the member shall be
- 16 reappointed subject to the advice and consent of the Council. If a member is
- 17 not being reappointed, the Mayor shall deliver to the Council the Mayor's
- 18 recommendation from the two names submitted within 30 days of delivery of the
- 19 two names to the Mayor. If the Mayor fails to timely make a recommendation
- 20 from the two names submitted, the Councilor may appoint one of the two
- 21 recommended members subject to the advice and consent of the Council. The
 - 22 Mayor shall appoint the two at large members to the Albuquerque Arts Board
- : 23 with the advice and consent of the Council. The term of each member shall be
- 24 three years. The terms of the members shall be staggered so that three
- 25 members are eligible for reappointment or replacement each year.
 - (B) The Mayor may notify a Councilor in writing that his or her District
- 27 member's term has expired or the position is otherwise vacant and the
- 28 Councilor shall have 60 days to submit two recommended appointments to fill
- 29 that position. If the Councilor fails to submit two names within 60 days of
- 30 notification, the Mayor shall have the right to make the appointment subject to
- 31 the advice and consent of the City Council.
- 32 (C) Except as provided in this article, the qualifications, appointment and
- 33 conduct of the members of the Board and any of its subcommittees and the

- 1 organizational structure of the Board and its subcommittees shall be governed
- 2 by §§ 2-6-1-1 et seq.
- 3 (D) Members of the Board shall be broadly representative of all fields of the
- 4 visual arts and fine crafts. They shall include persons who are widely known for
- 5 their professional competence and experience in the arts and knowledgeable
- 6 lay persons.
- 7 (E) Conflict of Interest. This division (E) supplements § 2-6-1-4. A Board or a
- 8 subcommittee member having a financial interest in the outcome of any policy,
- 9 decision, or determination before the Board or subcommittee on which he
- 10 serves shall, as soon as possible after such interest becomes apparent,
- 11 disclose to each of the other members voting on the matter the nature of his
- 12 financial interest in the issue, and shall be disqualified from participating in any
- 13 debate, decision or vote relating thereto.
- 14 SECTION 8. CHAPTER 10: AMUSEMENTS, RECREATION AND CULTURE,
- 15 ARTICLE 6: LIBRARIES, Parts 2 through 4, are hereby amended as follows:
- 16 §10-6-2 COMPOSITION.
- 17 (A) The Library Advisory Board shall consist of 16 (sixteen) appointed
- 18 members, and 1 (one) assigned member. There shall be 1 (one) member of the
- 19 Board appointed from each City Council District, 2 (two) members appointed by
- 20 the Mayor, who serve at large; 1 (one) assigned member from the recognized
- 21 support organization of the Albuquerque Bernalillo County Library Foundation,
 - and 4 (four) appointed by the Bernalillo County Commission, who also serve at
 - large.
 - (B) When an appointed vacancy on the Board occurs, the Councilor
 - representing the District in which the vacating member of the Board resides.
 - shall nominate two members to the Board who reside in his or her respective
 - 7 Council District and the Mayor shall appoint one of these recommended
- 28 members; provided, however, if a member is eligible for reappointment to the
- 29 Board and the Councilor in whose District that member resides desires to
- 30 reappoint the member, the Councilor shall so notify the Council and the member
- 31 shall be reappointed subject to the advice and consent of the Council. If a
- 32 member is not being reappointed, the Mayor shall deliver to the Council the
- 33 Mayor's recommendation from the two names submitted within 30 days of

- 1 delivery of the two names to the Mayor. If the Mayor fails to timely make a

- 5 member's term has expired or the position is otherwise vacant and the
- 6 Councilor shall have 60 days to submit two recommended appointments to fill
- 7 that position. If the Councilor fails to submit two names within 60 days of
- 8 notification, the Mayor shall have the right to make the appointment subject to
- 9 the advice and consent of the City Council. The Mayor shall appoint the 2 (two)
- 10 at large members to the Board with the advice and consent of the Council. The
- 11 term of each appointed member shall be three years. The terms of the members
- 12 shall be staggered so that three members are eligible for reappointment or
- 13 replacement each year.
- 14 (C) Except as provided in this article, the qualifications, appointment and
- 15 conduct of the members of the Board and any of its subcommittees and the
- 16 organizational structure of the Board and its subcommittees shall be governed
- 17 by §§ 2-6-1-1 et seq., the Public Boards, Commissions and Committees
- 18 Ordinance.
- 19 (D) The Board shall establish and adopt bylaws as may be necessary to
- 20 conduct elections, provide notice of meetings and otherwise govern its
- 21 proceedings.
- 22 (E) Members of the Board shall be broadly representative of all fields of the
- 23 literary arts. They shall include persons who are widely known for their
- 24 professional competence and experience in the aforementioned fields and
- 25 knowledgeable lay persons.
- 26 (F) Appointed members of the Board may not serve on the board of directors
 - for any recognized organization supporting the Albuquerque Bernalillo County
- 28 Library except for the position assigned by title described in section (A) of this
- 29 provision. Each assigned member shall serve on the Board until the term
 - 30 expires with the respective organization.
- 31 (G) Conflict of Interest. This provision (G) supplements § 2-6-1-4. A Board or
- 32 a subcommittee member having a financial interest in the outcome of any
- 33 policy, decision, or determination before the Board or subcommittee on which

- 9 SECTION 9. SEVERABILITY CLAUSE. If any section, paragraph, sentence,
- 10 clause, work or phrase of this ordinance is for any reason held to be invalid or
- 11 unenforceable by any court of competent jurisdiction, such decision shall not
- 12 affect the validity of the remaining provisions of this ordinance and each
- 13 section, paragraph, sentence, clause, word, or phrase thereof irrespective of
- 14 any provision being declared unconstitutional or otherwise invalid.
- 15 SECTION 10. COMPILATION. This ordinance shall be incorporated in and
 - made part of the Revised Ordinances of Albuquerque, New Mexico, 1994.
 - SECTION 11. EFFECTIVE DATE. This ordinance shall take effect five days after publication by title and general summary.
