1 RESOLUTION

2 REVISING THE REPORTING REQUIREMENTS REGARDING THE EFFORTS OF

3 THE HOMELESS COORDINATING COUNCIL.

4 WHEREAS, On June 29, 2020, The City Council approved Resolution R-20-

5 72, which authorized support for a Memorandum of Understanding with

6 Bernalillo County and the University of New Mexico for the creation and

7 operation of the Homeless Coordinating Council (HCC); and

8 WHEREAS, Section 4 of R-20-72 required that "the City of Albuquerque

9 shall provide periodic reports to the Albuquerque Bernalillo County

10 Government Commission (ABCGC) on the efforts and recommendations of the

11 HCC"; and

12 WHEREAS, ABCGC meetings are normally held monthly, but in some cases

13 may be cancelled or postponed depending on the volume of pending action

14 items and presentations within its purview; and

15 WHEREAS, the intent of the reporting requirement for the HCC was to keep

16 members of the ABCGC, and City Council, abreast of its efforts and

17 recommendations; and

18 WHEREAS, no presentations have been made to the ABCGC since the

19 adoption of R-20-72; and

20 WHEREAS, it is timely and appropriate to inform the members of the

21 ABCGC and City Councilors of the HCC's recommendations as they decide on

22 policies and budget appropriations for the Gateway Facility/Facilities and the

23 Crisis Triage Center.

24 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF

25 ALBUQUERQUE:

5 **recommendations of the HCC. In the event that a monthly Commission**
6 **meeting is cancelled, the report shall be made to the City Council at its next**
7 **scheduled meeting.**

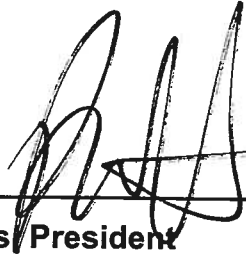

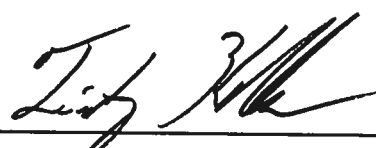
