1 RESOLUTION
2 **COMMISSIONING AN UPDATE TO THE 2014 SOCIAL SERVICE GAP ANALYSIS**
3 **STUDY AND ADJUSTING FISCAL YEAR 2021 GENERAL FUND**
4 **APPROPRIATIONS TO PROVIDE FUNDING FOR THAT PURPOSE.**

5 **WHEREAS, the City Council approved Resolution F/S R-14-55 on June 9,**
6 **2014, which commissioned a study to assess the gaps in funding for the City,**
7 **County and State social service programs; and**

8 **WHEREAS, the UNM Center for Education Research and Policy completed**
9 **the commissioned analysis in October, 2014, and included estimated numbers**
10 **of persons who have moderate to severe behavioral health issues, and an**
11 **inventory of the types of related services available to meet these needs; and**

12 **WHEREAS, one of the deliverables produced with the gap analysis study**
13 **included an interactive map showing the location and detail of the services**
14 **providers, which can be found at [https://ccpi.unm.edu/visualizations/mental-](https://ccpi.unm.edu/visualizations/mental-behavioral-health-service-providers)**
15 **[behavioral-health-service-providers](https://ccpi.unm.edu/visualizations/mental-behavioral-health-service-providers); and**

16 **WHEREAS, the passage of time and dynamic community conditions**
17 **necessitate that the behavioral health services gap study be updated to**
18 **provide more useful and relevant information for policy makers.**

19 **BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF**
20 **ALBUQUERQUE:**

21 **SECTION 1. The Director of Council Services is hereby authorized to enter**
22 **into an agreement with a consultant to assist in updating the study assessing**
23 **the gaps in the City, County and State's provision of services for mental health**
24 **service.**
