Borrego 1 RESOLUTION 2 EXTENDING THE MORATORIUM ESTABLISHED FOR THE SECTION OF IRVING BOULEVARD FROM KAYENTA PLACE TO RIO LOS PIÑOS DRIVE 3 THROUGH DECEMBER 31ST 2021. 4 WHEREAS, Resolution 17-228 established a moratorium on roadway 5 improvements for the section of Irving Boulevard from Kayenta Place to Rio 6 Los Piños Drive until January 1St 2020. Road work associated with general 7 maintenance, utility repairs and improvements or emergency safety 8 improvements were excluded from the moratorium; and 9 WHEREAS, Resolution 19-186 extended the moratorium through 10 Bracketed/Strikethrough Material] - Deletion 11 December 31st, 2020; and [Bracketed/Underscored Material] - New WHEREAS, through consultation between the City Councilor to 12 Albuquerque City Council District 5 and residents of the neighborhoods 13 adjacent to Irving, it was determined the moratorium and accompanying 14 15 exclusion should be extended an additional calendar year. BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY 16 17 OF ALBUQUERQUE: Section 1. The moratorium on roadway improvements for Irving 18 Boulevard from Kayenta Place to Rio Los Piños Drive is extended through 19 December 31st 2021. Road work associated with general maintenance, utility 20 repairs, emergency improvements and traffic calming are excluded from this 21 22 moratorium. 23 Section 2. SEVERABILITY CLAUSE. If any section, paragraph, sentence, clause, word or phrase of this resolution is for any reason held to 24 25 be invalid or unenforceable by any court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this 26
