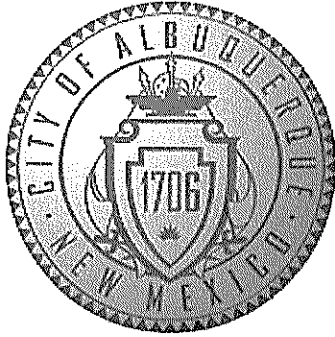

A native of Monticello, Indiana, Mr. Scott Smith moved to Albuquerque, New Mexico in 2017 following 11 years of service as a commissioned officer in the U.S. Army.
