1 RESOLUTION

2 AMENDING THE ADOPTED CAPITAL IMPLEMENTATION PROGRAM OF THE
3 CITY OF ALBUQUERQUE BY APPROVING NEW PROJECTS AND CHANGING
4 THE SCOPE OF EXISTING PROJECTS RELATING TO DISTRICT 2 COUNCIL
5 NEIGHBORHOOD SET-ASIDES.

6 WHEREAS, the Capital Implementation Program of the City of Albuquerque
7 is governed by the requirements established under Section 2-12-4 ROA, 1994,
8 which provides for amendments to the approved program; and

9 WHEREAS, the Council adopted Resolution C/S R-21-128 which approved
10 the programming of funds and projects for the 2021-2030 Decade Plan for
11 Capital Improvements including \$9,000,000 for Council Neighborhood Set-
12 Asides; and

13 WHEREAS, Exhibit A to Resolution C/S R-21-128 included the individual
14 project budgets and descriptions for the Council Neighborhood Set-Asides;
15 listed per City Council district; and

16 WHEREAS, the Councilor for District 2 wishes to make available Council
17 Neighborhood Set-Aside funding for additional community enhancement
18 projects that benefit the district; and

19 WHEREAS, appropriation of these funds to this project are timely and
20 necessary for the City to serve its citizens.

21 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
22 ALBUQUERQUE:

23 SECTION 1. That Exhibit A to C/S R-21-120 entitled "2021 GO Bond Program
24 Councilor Set-Asides" is hereby amended as follows:

25 A. On page 1, Council District 2 Set Aside section, delete the section
26 entitled "Parks and Recreation."


