1 RESOLUTION

2 ESTABLISHING FEDERAL PRIORITIES FOR THE CITY OF ALBUQUERQUE
3 FOR 2021 (FY21-FY22) TO THE COMMUNITY PROJECT PROGRAM FUNDS OF
4 THE 117TH CONGRESS OF THE UNITED STATES.

5 WHEREAS, the House of Representatives and the Senate of the 117th
6 Congress of the United States, have established a Community Project Fund to
7 assist in the development and operation of public infrastructure and
8 community-based service programs for state and local government; and

9 WHEREAS, the members of the New Mexico Delegation to the 117th
10 Congress have issued calls to the communities of New Mexico to submit
11 applications for the Community Project Fund; and

12 WHEREAS, staff from the Mayor's Office, multiple City Departments and
13 the Council Services Department have submitted applications for projects
14 through direction of the Mayor and City Councilors; and

15 WHEREAS, § 2-2-2 of the Albuquerque Code of Ordinances authorizes the
16 Intergovernmental Legislative Relations Committee to prepare a legislative
17 program for submission prior to December 30th, of each calendar year to the
18 Mayor and Council for their approval and to draft appropriate legislation on
19 behalf of the City prior to each session of the United States Congress; and

20 WHEREAS, the Community Projects Fund is a new program instituted by
21 the 117th Congress after the December submission of the City's Priorities
22 Resolution; and

23 WHEREAS, the Intergovernmental Legislative Relations Committee
24 convened in July of 2021 and approved a list of projects to be submitted to the
25 City Council as the City of Albuquerque's Community Project Fund

9 lists of City Federal Priorities adopted through R-20-113.

11 members of the Congressional Delegation.




