EC-19-301 appointed Mr. Gary Eyster to the Environmental Planning Commission (EPC), with his first term expiring 01/01/2022. This communication will re-appoint Mr. Eyster for a second and final three-year term, which will expire January 1<sup>st</sup>, 2025.

Mr. Eyster was a registered Civil Engineer from 1978 until his retirement in 2012 and he operated a residential design/build firm in Albuquerque for 15 years. He also served on the board of the Nob Hill

Neighborhood Association during the development of the 2007 Nob Hill/Highland Sector Plan and the Integrated Development Ordinance. Mr. Eyster believes the close relationship of commercial and residential development in Nob Hill creates quality of life and would like to see some of these principles applied elsewhere in the city.
