### ORDINANCE

Amending The Municipal Solid Waste Landfill Tire Disposal Fee (Jones, by request)

AMENDING THE MUNICIPAL SOLID WASTE LANDFILL TIRE DISPOSAL FEE.

BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF ALBUQUERQUE:

SECTION 1. The Municipal Solid Waste Rate Table is hereby amended to incorporate a change to the Landfill Tire Disposal fee, per the attached appendix.

SECTION 2. SEVERABILITY CLAUSE. If any section, paragraph, sentence, clause, work or phrase of this ordinance is for any reason held to be invalid or unenforceable by any court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this ordinance and each section, paragraph, sentence, clause, word, or phrase thereof irrespective of any provision being declared unconstitutional or otherwise invalid.

SECTION 3. COMPILATION. Section 1 of this ordinance shall be incorporated in and made part of the Revised Ordinance of Albuquerque, New Mexico, 1994.

SECTION 4. EFFECTIVE DATE. This ordinance shall take effect five days after publication by title and general summary.
