RESOLUTION

Amending The Adopted Capital Implementation Program Of The City Of Albuquerque By Approving New Projects And Changing The Scope Of Existing Projects Relating To District 2 Council Neighborhood Set-Asides (Benton)

AMENDING THE ADOPTED CAPITAL IMPLEMENTATION PROGRAM OF THE CITY OF

ALBUQUERQUE BY APPROVING NEW PROJECTS AND CHANGING THE SCOPE OF EXISTING PROJECTS RELATING TO DISTRICT 2 COUNCIL NEIGHBORHOOD SET-ASIDES.

WHEREAS, the Capital Implementation Program of the City of Albuquerque is governed by the requirements established under Section 2-12-4 ROA, 1994, which provides for amendments to the approved program; and

WHEREAS, the Council adopted Resolution F/S 2 R-19-120 which approved the programming of funds and projects for the 2019-2028 Decade Plan for Capital Improvements including \$9,000,000 for Council Neighborhood Set-Asides; and

WHEREAS, Exhibit A to Resolution F/S 2 R-19-120 included the individual project budgets and descriptions for the Council Neighborhood Set-Asides; listed per City Council district; and

WHEREAS, the Councilor for District 2 wishes to make available Council Neighborhood Set-Aside funding for Public Safety projects that benefit the district; and

WHEREAS, appropriation of these funds to this project are timely and necessary for the City to serve its citizens.

BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF ALBUQUERQUE:

SECTION 1. That Exhibit A to F/S 2 R-19-120 entitled "2019 GO Bond Councilor Set-Asides" is hereby amended as follows:

- A. On page 1, Council District 2 Set Aside section, line entitled "Senior, Family, Community Center and Community Enhancements Projects," reduce the amount by \$10,000, from \$250,000 to \$240,000.
- B. On page 2, Council District 2 Set Aside section, line entitled "Parks and Recreation Projects," reduce the amount by \$10,000, from \$250,000 to \$240,000.
- C. On page 2, Council District 2 Set Aside section, line entitled "Streets Projects," reduce the amount by \$10,000, from \$500,000 to \$490,000.
- D. On page 2, Council District 2 Set Aside section, after section, after the Street Projects section, insert the following:

"Public Safety Projects                      \$30,000

Plan, design, develop, study, construct, modernize, automate, renovate, rehabilitate, expand, repair, and otherwise improve, and acquire land, buildings, property, vehicles, apparatus, and equipment for police and fire/rescue departments and public safety facilities that benefit District 2."
