RESOLUTION

Approving And Authorizing The Filing Of A Grant Application For A Food Service Program For Children With The New Mexico Department Of Children, Youth And Families And Providing An Appropriation To The Department Of Family And Community Services/Division Of Child And Family Development (Sanchez, by request)

APPROVING AND AUTHORIZING THE FILING OF A GRANT APPLICATION FOR A FOOD SERVICE PROGRAM FOR CHILDREN WITH THE NEW MEXICO DEPARTMENT OF CHILDREN, YOUTH AND FAMILIES AND PROVIDING AN APPROPRIATION TO THE DEPARTMENT OF FAMILY AND COMMUNITY SERVICES/DIVISION OF CHILD AND FAMILY DEVELOPMENT.

WHEREAS, the City of Albuquerque is desirous of providing nutritious breakfasts, lunches and snacks to 870 economically disadvantaged children served through its child care development program; and

WHEREAS, the State of New Mexico has made available funding to reimburse the City for the cost of such nutritious meals.

BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF ALBUQUERQUE:

Section 1. That the Mayor is further authorized to execute a grant agreement with the New Mexico Department of Children, Youth and Families and do all things necessary and proper to implement the program.

Section 2. The funds in the amount of Four Hundred Eighty Thousand Dollars (\$480,000) are hereby appropriated to the Department of Family and Community Services for child care food program in Operating Grants Fund (265) for Fiscal Year 2013.

Section 3. That funds in the amount of Nine Thousand Seven Hundred Forty Four Dollars (\$9,744) from the General Fund (110) are hereby appropriated to the Child Care Food Program in Operating Grants Fund (265) to cover indirect costs associated with this Grant in Fiscal Year 2013.
