### RESOLUTION

Amending The One-Year Objectives For The City Of Albuquerque For Fiscal Year 2016 (Peña)  
AMENDING THE ONE-YEAR OBJECTIVES FOR THE CITY OF ALBUQUERQUE FOR FISCAL YEAR 2016.

WHEREAS, on May 27, 2015, the City Council approved Resolution R-15-182 which established one-year objectives for the City for Fiscal Year 2016; and

WHEREAS, the Community and Cultural Engagement Goal, Objective 3, requires the

Cultural Services Department to provide to the City Council with attendance and performance measurements for the Alamosa and Westgate Libraries, including a recommendation for the continued operation of those libraries; and

WHEREAS, the City Council desires a more complete assessment of the performance of all City public libraries.

BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF ALBUQUERQUE:

Section 1. That the Community and Cultural Engagement Goal, Objective 3, for Fiscal Year 2016 is hereby amended as follows:

“OBJECTIVE 3. The Cultural Services Department shall provide a performance and attendance report for all City Libraries for the calendar year 2015. Submit the final report to the City Council by the end of the third quarter of FY/16. (Cultural Services-Public Library)”
