While in graduate school, she served as a member of the King County Transportation Advisory Committee. At that time she rode the bus daily to the University of Washington. She has served on multiple professional and nonprofit boards and committees, and has an understanding of how boards and committees work. Her roles have varied from committee member, chair, board member and president of the major nursing science organization in the west, the Western Institute of Nursing.
