Mr. Lawyer has presented Transgender 101 more than 1000 times all over the state of New Mexico and has been instrumental in doing advocacy at the individual and policy levels. For instance, TGRCNM worked for several years with Albuquerque Public Schools to implement transgender student policy. He is a transgender man and a father and is working for equality and accessible resources for the entire transgender community. A resident of District 7, Mr. Lawyer will serve as a City Representative on the committee for the ordinance groups of Social Services and Multicultural Groups. His term will expire June 30, 2020.
