Albuquerque Public School (APS) request(s) the aforementioned action(s) for all or a portion of SAN MATEO PLACE NE located south of CUTLER AV NE and north of INTERSTATE 40, containing approximately .398 acre(s). (M-21)

Request: This is a request for vacation of public right of way for a portion of San Mateo Place NE.

Per Section 14-16-6-6(K)(2) of the IDO, the Development Review Board (DRB) shall make a recommendation and forward the application to City Council for inclusion on the consent agenda for approval without first going to any Council committee if the vacation involves: 1) More than 500 square feet or the entire width of a platted alley; 2) More than 5000 square feet or the entire street width of a street, including any or all of the public right-of-way. The square footage of this vacation is approximately 17,200 square feet and is the entire width of the street, therefore it is a DRB recommendation to City Council.

At the July 17, 2019 public hearing, the DRB had a consensus to recommend approval of the request to the City Council of the proposed vacation as shown on Exhibit "A" (attached) in the Planning file under Project# PR- 2019-002485, based on the recommended Findings, noted in the NOD, per Section 14-16-6-6(K) of the IDO.
