Since 2000, he has worked for New Mexico Mutual as the Web Administrator and Project Supervisor. In 2005, he became the Director of Information Technology at New Mexico Mutual and is still working in this capacity. He leads a 25 member IT team and manages a \$10 million budget. He drives the companies IT strategy, serves as the Chair of the IT Steering Committee, and has led efforts to decrease company operations cost by 25%. Mr. Thackaberry has also served as the IT Committee Chair and Member for the American Association of State Compensations Insurance Funds (AASCIF). In addition, he is a graduate of Leadership New Mexico's Connect Program and is a Connect Program Curriculum Committee member. Mr. Thackaberry holds a Bachelor of Arts, in English from Creighton University in Omaha, NE and a Master of Business Administration from Park University in Parkville, MO.
