Approving And Authorizing A Grant Application From The Dennis Friends Foundation And
Providing An Appropriation To The City Of Albuquerque Animal Welfare Department In Fiscal Year

2020 & 2021 (Davis, by request)

APPROVING AND AUTHORIZING A GRANT APPLICATION FROM THE DENNIS FRIENDS FOUNDATION AND PROVIDING AN APPROPRIATION TO THE CITY OF ALBUQUERQUE ANIMAL WELFARE DEPARTMENT IN FISCAL YEAR 2020 & 2021.

WHEREAS, Dennis Friends Foundation wishes to grant the City of Albuquerque Animal Welfare Department to provide City residents assistance with pet sterilization vouchers, microchip identification and vaccinations for their companion animals at the mobile clinic vehicle; and

WHEREAS, the City of Albuquerque Animal Welfare Department will utilize the grant funds to purchase rabies vaccination, microchips and pet sterilization vouchers; and

WHEREAS, grant funds for the amount of \$300,000 for this purpose are available to the City of Albuquerque Animal Welfare Department from the Fiscal Year 2020 & 2021 Dennis Friends Foundation; and

WHEREAS, the City of Albuquerque Animal Welfare Department desires to accept these funds, which require no City match or indirect overhead to support this project.

BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF ALBUQUERQUE:

Section 1. That the attached application for the Dennis Friends Foundation for the amount of \$300,000 in Foundation funds is hereby approved, and its acceptance and filing with the appropriate official or office is and in all respect approved.

Section 2. That funds in the amount of \$300,000 in Foundation monies from Dennis Friends Foundation are hereby appropriated to the City of Albuquerque Animal Welfare Department for Fiscal Year 2020 & 2021.
