New Mexican, born in Albuquerque, NM, raised in northern New Mexico, graduated high school in Alamogordo, NM, and is a first generation college graduate, from the University of New Mexico. Mr. Trujillo, currently is employed with Presbyterian Health services, where he garnered a new-found interest and passion for community health and well-being. He currently works in the Urology departments of the organization, and has been employed with the company for a year and a half. Mr. Trujillo, has always had an eclectic and artistic nature. Always drawn to art, music, and culture; he too is an artist in his own right. Trujillo, has always been interested in social activism, since being an undergraduate student. Mr. Trujillo, has interned for the Democratic Party of New Mexico, has served local, district and state roles of leadership with LULAC - the largest & oldest Hispanic civil rights organization in the nation.
