He also served as program director at the New Mexico Public Education Department for nearly 13 years. Dr. Sanchez is a Veteran and served as a Commander in the U.S. Navy. He brings skills and expertise as a strong team leader, results-oriented, strategic planner, operations management, health policy, workforce development, community organizer, and advocate. Dr. Sánchez is a native of New Mexico with strong ties to both the Hispanic/Latino and Native American communities. Dr. Sanchez's academic career includes a Doctor of Philosophy in Human Development and Family Studies from the University of New Mexico, Masters and Bachelors of Business Administration from New Mexico Highlands University, a Certificate in Naval Integrated Logistics from the Navy Supply Corps School, Athens, Georgia and Advanced Change Management Certification.
