In that capacity, Ms. Mourning Brown turned around DVR by reducing the vacancy rate of counselors, increasing federal funding, providing much-needed employment opportunities for people with disability, and increasing public awareness and community involvement. She has high-level management and administration experience with nonprofit and government agencies in both Albuquerque and Denver. Ms. Mourning Brown has an adult child with disabilities and has forged the annals of community services on her behalf.
